

### Overview of the Consolidated Grant

The state consolidates a variety of statewide funding sources to meet a variety of mobility needs:

- Public transportation within and between rural communities
- Tribal transportation
- Transportation services between cities
- Purchases of new buses, vans, and equipment
- Public transportation services to older adults and people with disabilities (specialized transportation)

One of the only funding competitions for private nonprofit and human service agency transportation providers.

PSRC works with the Coordinated Mobility and Accessibility Committee to prioritize projects.









PSRC announced call for projects for regional priority ranking process:

- Detailed timeline
- Application review guidance (including review factors, additional resources)

Training was provided on July 31 to review the process and factors.





Second grant cycle with **sponsor presentations**.

All project applicants provided a short presentation (and Q&A) on Zoom.





PSRC conducted **CMAC deliberation** in early December 2024 to submit rankings to the state by January.

PSRC Executive Board reviewed the recommended rankings as a final step of this process.



## Regional Priority Ranking Factors for PSRC Assessment

- Preservation of Existing Programs
- Addressing High Priority Strategies in the Coordinated Mobility Plan
- Service Coordination
- Performance Measures and Targets
- Equitable Engagement and Communications





#### **Additional Considerations for Deliberation**

## Considerations from 2022 process used <u>again</u> in 2024:

- Acknowledge the importance of the largest county service providers (in terms of number of rides provided)
- Geographical distribution of priority rankings
- Project types
- Agency equity (number of projects per agency)
- Compelling cases for agencies with limited resources
- Strategic application of federal/state funds
- Coordination



### **Additional Considerations for Deliberation**

#### Newly added considerations for the 2024 process:

- Vehicle characteristics (vehicle mileage or age, vehicle configuration and capacity), particularly relating to capital projects
- Consideration given to vehicle projects applied for by agencies new to the grant process to support existing operations
- Precedent for past rankings for projects that have competed in this competition in past grant cycles
- Compelling cases for new agencies applying for existing projects
- Unique populations currently not well served by specialized transportation



## 2025-2027 Projects Awarded Grants

PSRC received 24 projects for the 2025-2027 biennium:

- 11 ABC-ranked projects (3 A's, 3 B's, 5 C's)
- 13 D-ranked projects

#### Final Consolidated Grant Awards:

- 17 projects received funding from WSDOT
- All A & B ranking projects were funded
- Two C- and 5 D-ranking projects were not funded by the state

### **Lessons Learned**

- Applicant training or support on equity factor: Provide clear guidance and expectations on the Equitable Engagement & Communications factor.
- Clarify ranking factors: Arrange CMAC discussions on ranking factors and potential "additional considerations" earlier.
- Strengthen performance measures: Discuss performance measures tailored to capital projects and remind of guidance on equity-focused measures.
- Respect all project types: Ensure all project types, including microtransit, are fairly considered within the ranking process.
