MINUTES

CALL TO ORDER AND ROLL CALL

The meeting of the Executive Board was called to order at 10:01 AM by Executive Dave Somers, PSRC President. A video of the meeting was streamed live as well as recorded and is available for viewing on PSRC's website. A call-in number was provided on the meeting agenda for members of the public to call in by phone and listen live. Roll call determined attendance and that a quorum was present.

COMMUNICATIONS AND PUBLIC COMMENT

There were no public comments received.

PRESIDENT'S REMARKS

President Dave Somers reminded the board that it would not meet in November and would hold its December meeting on the 4th. He noted that the board would conduct Executive Director Josh Brown's annual performance review at that meeting. Board members received a survey from PSRC's HR consultant, Amy Efroymsen, on September 29, and were asked to complete it by October 24 to provide input for the review.

EXECUTIVE DIRECTOR'S REPORT

Josh Brown Updates and Announcements:

- Reported that EDA funding was impacted by the government shutdown, affecting \$25,000 of PSRC's \$40 million biennial budget.
- Highlighted PSRC's All Staff Retreat at the Tacoma Art Museum. He thanked Executive Ryan Mello and Councilmember Kristina Walker for participating.
- Reported that PSRC partnered with Port of Seattle to host Seattle-Tacoma International Airport tours.
- Attended the National Association of Regional Councils Executive Directors Conference, where the government shutdown and Surface Transportation Reauthorization were key discussion topics.
- Participated in the Bellevue Downtown Association Study Tour to Denver.
- Attended the Master Builders Association of King and Snohomish Counties Housing Solutions Breakfast.

- Conducted additional outreach, including meeting with Councilmember Sarah Perry and Senator Curtis King.

LEGISLATIVE UPDATE

Robin Koskey, Director of Government Relations and Communications, provided the board with an update on key federal and state policy updates.

COMMITTEE REPORTS

Vice President and Operations Committee Chair Executive Mello reported that the committee recommended Executive Board approval of vouchers dated September 4, through October 8, 2025, in the Amount of \$1,423,488.65.

The committee is working on the development of the draft Supplemental Budget and Work Program. Andrew Werfelmann, Budget Manager, provided an overview of the budget assumptions, including expected revenues and expenditures. The full draft supplemental budget is anticipated to be reviewed at the Operations Committee's December meeting. Beginning in the new year, policy boards will have the opportunity to review the draft budget and provide feedback to staff.

The motion passed unanimously.

DISCUSSION ITEMS: REGIONAL COMPREHENSIVE CLIMATE ACTION PLAN

Sara Hetrick, Puget Sound Clean Air Agency (PSCAA), provided a briefing on the development of the Regional Comprehensive Climate Action Plan (CCAP), funded through the U.S. Environmental Protection Agency's Climate Pollution Reduction Grant Program. PSCAA, in collaboration with PSRC, the four counties, and several cities, is leading the regional planning effort. The Priority Climate Action Plan was submitted to the EPA in March 2024, and the CCAP is due by December 2025. A draft plan was expected to be released for public comment in October.

The board discussed PSRC's ongoing collaboration with regional partners to reduce greenhouse gas emissions and prepare for climate impacts, consistent with VISION 2050 and the Regional Transportation Plan. Further discussions will be held in the coming months to align the CCAP with the draft RTP currently under development.

DISCUSSION ITEM: 2025 Housing Monitoring Update: The Year of Policy Change

This agenda item was postponed.

DISCUSSION ITEM: REGIONAL CENTERS UPDATE

Liz Underwood-Bultmann and Nancy Ferber provided an update on the process to monitor and redesignate regional centers as outlined in the Regional Centers Framework. Staff reviewed the purpose of regional growth and manufacturing/industrial centers in guiding growth, supporting economic development and prioritizing transportation investments. The redesignation process, following the 2024 comprehensive plan updates, will evaluate whether existing centers meet adopted eligibility and designation criteria.

The board was briefed on key policy issues discussed by the Regional Staff Committee and Growth Management Policy Board, including subarea planning, density requirements and walkability for regional growth centers.

In the coming months, the Growth Management Policy Board will provide recommendations to the Executive Board regarding the redesignation of existing regional centers and the potential designation of new centers.

DISCUSSION ITEM: REGIONAL TRANSPORTATION PLAN DRAFT PLAN DEVELOPMENT

Kelly McGourty and Craig Helmann briefed the board on progress to develop the Regional Transportation Plan (RTP), scheduled for adoption in 2026. Staff reviewed key milestones achieved, including completion of the Current Transportation System Report, collection of proposed investments through 2050, transportation funding forecasts, and extensive public outreach through community events and regional meetings.

The Transportation Policy Board directed staff to advance one of four scenarios into the draft plan, which is scheduled for public release in December 2025. Ongoing work includes preparing the Future Transportation System Report, conducting a regional transit access assessment, and refining the financial strategy.

The board was updated on upcoming steps and decision points leading to the release of the draft RTP for public comment.

OTHER BUSINESS

There was no other business brought before the board.

NEXT MEETING

The board will not meet in November. The next meeting is scheduled for Thursday, December 4, 2025, from 10:00 a.m. to 12:00 p.m.

ADJOURN

The meeting was adjourned at 11:46 a.m.

IN BRIEF

The fourth year of the Equity Advisory Committee (EAC) has been successful in moving equity initiatives forward at PSRC. Below please find a brief overview of the outreach process for new EAC members and background information about the proposed roster for 2026.

RECOMMENDED ACTION

The Executive Director recommends that the Executive Board act to approve the proposed roster for the Equity Advisory Committee.

DISCUSSION

Equity is a key policy area in [VISION 2050](#), the region's long-range plan for growth. VISION 2050 calls for PSRC to develop a plan and commit resources for an equity advisory group that can provide feedback on and help implement the Regional Equity Strategy.

The EAC was officially formed in November of 2021. Over the past four years, the EAC has provided input on numerous PSRC initiatives including the Regional Transportation Plan, Regional Housing Strategy, Regional Economic Strategy, Regional Equity Strategy, and Project Selection. At the end of 2025, there were four EAC members who either stepped down, or had fulfilled their two-year term commitment.

Over the course of Fall 2025, PSRC conducted outreach for the Equity Advisory Committee. As a result of this outreach, PSRC received 34 applications from across the region. Staff developed a rubric to guide the application review process with current

EAC members, who shared their insights from serving on the EAC to help select eleven interviewees. Applications were evaluated based on the quality of their responses, experience reducing racial inequities, connection to community, and other equity considerations.

Currently, the EAC includes a proposed roster consisting of 20 members, representing a range of experience and expertise related to equity issues. The five new members proposed for the 2026 cohort include:

King County

Erin Bryant-Thomas | Pronouns: she/her | Race/Ethnicity: Black/African American

Erin currently lives in Auburn. She is a Human Services Manager for the City of SeaTac and a student at Evergreen State College. As a Human Services Manager, she focuses on root causes, and advocates for solutions that are community-informed, equity-centered and coordinated across sectors. She also has deep roots in community organizing where she's focused on housing stability, equitable education, employment access and culturally responsive care.

Rhea Biswas | Pronouns: she/her | Race/Ethnicity: Asian

Rhea is a senior at Eastlake High School in Sammamish. She also serves as a Health and Safety consultant where she leads workshops on water and hygiene safety. Additionally, she was a member of PSRC's Summer Planning Academy (SPA). She is passionate about community engagement with underrepresented groups and reducing racial disparities in access to transportation and housing.

Kitsap County

Gabriele A. Ituarte | Pronouns: she/her | Race/Ethnicity: Hispanic/Latina

Gabriele lives in Bremerton. She has 30+ years of experience working with the Latino community and seven years of experience advocating in Kitsap County for marginalized groups. She currently serves as the Executive Director of the We Are Better Together Foundation, where she elevates underrepresented voices and promotes accessible messaging that resonates across communities, primarily focusing on language access.

Pierce County

Sophia Lana Castro | Pronouns: she/her | Race/Ethnicity: Asian

Sophia is a freshman at Pacific Lutheran University. Prior to attending college, Sophia was involved in the Lakewood Youth Council and served as a Student Ambassador for Student Achievement Support Services, helping marginalized students with their post-secondary education journeys. She was also an intern for TurnUp, where she encouraged youth to be more civically engaged.

Snohomish County

Vivian Obah | Pronouns: she/her | Race/Ethnicity: Black/African American

Vivian currently lives in Mill Creek and serves as the Executive Director of the Helping Hands Project Organization where she expands access to affordable housing and works with small immigrant and minority-owned businesses. She also currently sits on the State Advisory Council on Homelessness.

NEXT STEPS

If the Executive Board approves the roster on December 4, 2025, the 2026 cohort of the Equity Advisory Committee will join staff for an onboarding session in December and begin meeting with the EAC in January.

IN BRIEF

Following the Executive Board's direction, PSRC staff have been working to prepare recommendations for the state legislature ahead of the 2026 legislative session. Staff will brief the Executive Board on the process for adopting legislative priorities and request approval of the 2026 Recommendations to the State Legislature.

RECOMMENDED ACTION

Adopt the proposed Recommendations to the 2026 State Legislature.

DISCUSSION

Last year, the Executive Board adopted recommendations to the 2025 Washington State Legislature based on the region's adopted plans and policies in the areas of transportation, housing choices and affordability, climate change, and economic development. While these core priorities remain unchanged for 2026, PSRC staff are recommending updated language to reflect board feedback in several areas.

First, the recommendations have been streamlined to enhance readability. Second, new language acknowledges the economic uncertainty facing the region and emphasizes that local elected officials value consultation by state legislators on policy changes. Finally, the recommendations highlight the need for the implementation of newly adopted housing policies.

PSRC staff consulted with the Executive Board, Economic Development District Board, Growth Management Policy Board, and Transportation Policy Board on the 2026 recommendations in September, October, and November. Staff also briefed the Equity Advisory Committee (EAC) on the recommendations.

Draft Recommendations to the 2026 State Legislature



Puget Sound Regional Council

The Puget Sound Regional Council (PSRC) seeks to address regional growth through policies that advance affordable housing, connected transportation, sustainability and a strong economy. We acknowledge the challenging economic conditions facing our state and region, compounded by federal-level uncertainty and declining state revenue. PSRC values the Legislature's continued partnership and commitment to working with local governments and elected officials to implement shared priorities.

Keep the Region Moving Safely

A reliable, efficient transportation system is critical infrastructure to build a thriving region where people are connected to homes and jobs. All transportation investments should be planned and implemented with emphasis on safety to reduce deaths and serious injuries on the region's roadways.

- Sustain transportation investments to fully fund maintenance and preservation, ensure projects of regional significance are built, and provide tools to address local funding needs, the largest revenue gap for the region.
- Develop an alternative to the state gas tax through an equitable road usage charge or highway use fee system.
- Continue capital and workforce investment in the Washington State Ferries system to ensure reliable service.

Increase Housing Choices and Affordability

Housing affordability continues to be a top concern of residents and local elected officials in communities in the region. We need to build 620,000 more homes by 2044 and 50% of these homes need to be affordable to people earning less than half of the Area Median Income.

- Invest in operating and capital subsidies to create affordable homes to meet local needs and create homeownership opportunities for Black, Indigenous, and people of color (BIPOC) households.
- Adopt policies to increase housing supply in coordination with local governments to ensure practical and effective implementation.
- Establish the Housing Futures Center at the University of Washington to provide timely analysis and data-driven research for policymakers to address urgent housing needs in our state.

Significantly Reduce Greenhouse Gas Emissions

Enact legislation to respond to the urgent environmental, health, economic and equity threats of climate change through:

- Transit-focused land use.
- Multimodal transportation choices.
- Pricing the transportation system.
- Decarbonization of the transportation system, including freight, transit, passenger vehicles and fuels.

Sustain a Strong Economy

- Invest in workforce development programs to support workers and meet the needs of employers and a growing economy, including electrification of the transportation system.
- Commit resources to critical infrastructure to support economic development, including broadband.
- Support clean energy industry technology like Sustainable Aviation Fuel (SAF), offshore wind, fusion, hydrogen, and other emerging technologies.



Subject: **Regional Transportation Plan Development**

IN BRIEF

Work to develop the next Regional Transportation Plan (RTP) has been underway since early 2024. The board has been briefed on needed investments and the finances necessary to fund those investments, as well as performance metrics of four draft plan scenarios. The board has also been briefed on key topics to be included in the plan, such as climate, safety and the needs of residents with mobility challenges. Public outreach and engagement have also been underway and will continue as work progresses.

The draft plan is anticipated to be released for public review and comment between mid-December and the end of January 2026. At the December meeting, staff will provide an overview of the many elements that will be included in the draft plan, a summary of public outreach to date, and the approach of the RTP Engagement Hub.

DISCUSSION

Over the last 20 months, steady progress has been made towards the development of the next RTP. This has included identification of key policy priorities and adoption of the plan's scope of work, publication of a [Current Transportation System Report](#), discussion of future proposed investments and the plan's financial strategy, a summary of ongoing outreach and engagement, and briefings on key plan topics.

At the December meeting, staff will describe each of the elements to be included or addressed in the draft plan. Example topics include active transportation, climate, safety, health, transit access, maintenance and preservation, the financial strategy, the Coordinated Mobility Plan (which addresses the needs for people with mobility challenges) and a comprehensive system performance report.

The board will also be provided with a summary of the six regional public meetings, the last of which was held on October 30, as well as an overview of upcoming engagement opportunities in addition to the public comment period.

In addition, ahead of the draft plan release in mid-December several early documents are available on the [RTP Engagement Hub](#). Materials previously posted include the adopted RTP scope of work, the Current Transportation System Report, the Current Transportation System Visualization Tool, and details of the four plan scenarios analyzed over the summer and discussed in the fall. A Future Transportation System Report describing the investments and key performance results from the final scenario moving forward into the draft plan was recently published, as well as a list of the regional capacity projects included and a Future Transportation System Visualization Tool.
