2026–2050 Plan Development / What's New

- Scope of work reflecting current policy priorities
- Investments based on new comprehensive plans, current transit plans, new State Highway System Plan
- Updated plan consistency framework applied to all regional capacity projects
- Reassessment of financial strategy
- Evaluation of four plan scenarios
- Regional Safety Action Plan
- Regional Comprehensive Climate Action Plan

Public Feedback to Date – Regional Public Meetings

Seven RTP public meetings

- 300+ attendees
- Overall scenario preferences =
 - 23% Scenario 1, Current Funding
 - 18% Scenario 2A, More Than Today
 - 43% Scenario 2B, Focus on Maintenance & Transit
 - 16% Scenario 3, Maximum Investment



Public Feedback to Date – Regional Public Meetings

Summary themes from attendees:

- Different needs around the region – some communities more reliant on cars, fewer transit and walk/bike options
- Less interest in more roads, but more interest in *better* roads
 - maintenance is critical, functioning roads are the underpinning of all other modes



Public Feedback to Date – Regional Public Meetings

Summary themes from attendees:

- Transit investment ranked highly for majority of attendees – need more of it, more frequent and seamless connections
- Also calls for better connected and safer sidewalks and bicycle networks
- Accountability for investment – let's see results



Public Feedback to Date – Additional Outreach

- Online and community tabling surveys
 - ✓ ~300 responses
 - ✓ Similar comments regarding needs, concerns around:
 - Reliable transit with good connections
 - Traffic and road safety
 - Maintenance and preservation
 - Safer pedestrian and bicycle networks



Public Feedback to Date – Additional Outreach

Equity Advisory Committee key priorities = accessibility and affordability

Discussion themes:

- Need additional infrastructure but concerned about the additional costs to households
- The transportation system needs to meet the needs of people with low income, seniors and people of color, but these communities also experience the highest financial burdens

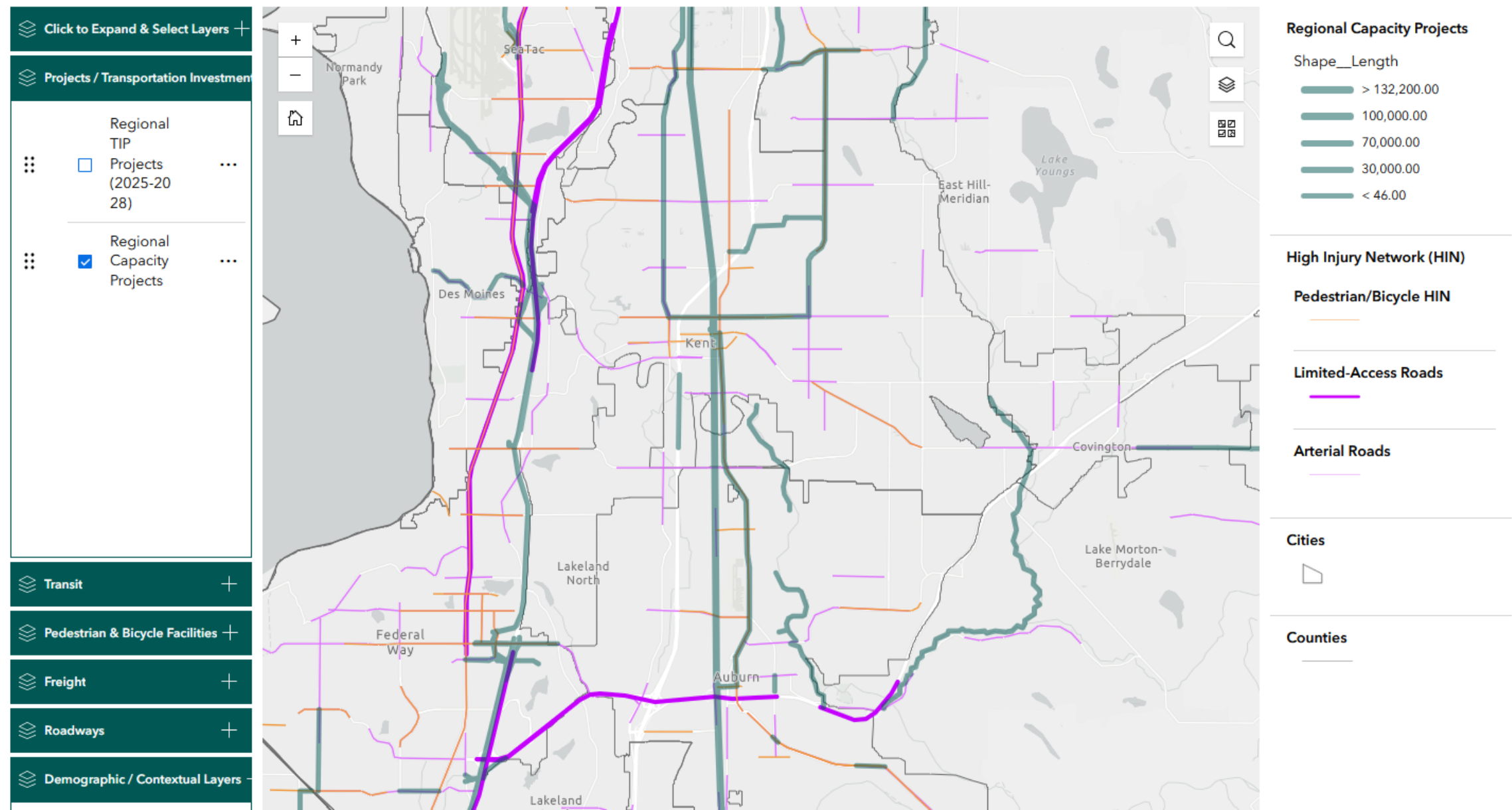

Draft Plan – Elements and Approach

- PSRC Board discussion items to date:
 - ✓ Investments and revenues
 - ✓ Major plan scenario results and key findings
 - *Including performance metrics and system gaps*
 - ✓ Financial strategy
 - ✓ Comprehensive Climate Action Plan

Draft Plan – Elements and Approach



- ❖ Draft plan includes more detailed:
 - Outreach and Engagement report
 - System Performance Report – *plus standalone information on climate, air, health, freight*
 - Maintenance and Preservation background
 - Financial Strategy background
 - Active Transportation Plan
 - Coordinated Mobility Plan



Draft Plan Highlights

- \$335 billion total cost – includes a wide mix of needed investments with a focus on maintenance and transit
 - Fully funding backlog, maintaining state of good repair into the future
 - *60% of plan costs*
 - Significant expansion of regional and local transit networks and service
 - *116 miles of light rail, doubling of bus rapid transit routes, 90% increase in transit service hours*



Draft Plan Highlights

- Significant progress on regional priorities
 - *33% growth in people and jobs by 2050*
 - *20% growth in total VMT, 12% reduction in VMT per capita*
 - *An almost tripling of transit trips by 2050*
 - *Walking and biking trips grow 83% and 58%, respectively*
 - *83% reduction in greenhouse gas emissions*



Draft Plan Highlights

- 83% of plan costs can be funded with current law revenues
- Proposes a flexible, practical approach for future new revenue sources
 - *Regional focus on road usage charge, transit sales tax, vehicle/license fees, county road levy*
- Recognizes unique local conditions and needs
- Acknowledges policy and implementation issues
- Calls for future work and collaboration



Draft Plan Action Items

- **Transportation Finance** – ongoing work program to advance transportation funding options, particularly to address local needs
- **Maintenance and Preservation** – continued work to improve estimation methodologies and data collection
- **Climate** – advance implementation of the Comprehensive Climate Action Plan; advance work to address climate impacts and vulnerabilities of the transportation system



Draft Plan Action Items

- **Future system gaps** – explore opportunities to address gaps in the future system, e.g. addressing transit gaps in alignment with the 2030 VISION and RTP update
- **Safety** – advance implementation of the Regional Safety Action Plan
- ❖ Plan also identifies future planning work “On the Horizon”



Board Action and Schedule to Plan Adoption

- **December 11 TPB ACTION** – authorized staff to release the draft plan for public comment
- **Public Comment Period** – open from December 15, 2025 to February 2, 2026
 - Additional outreach to focus groups, key stakeholders
- **February through April 2026** – board reviews public comments, finalizes plan document
- **May 2026** – General Assembly plan adoption
