### **CALL TO ORDER AND ROLL CALL**

The meeting was called to order at 10:01 a.m. by Councilmember Ed Prince, Chair.

### **COMMUNICATIONS AND PUBLIC COMMENT**

There was no public comment.

### **CHAIR'S REPORT**

Chair Prince announced that the Growth Management Policy Board meetings will be moving to the third Thursday of the month starting in 2026. He also thanked outgoing members of the board.

### **DIRECTOR'S REPORT**

Director of Growth Management Paul Inghram welcomed the board and introduced Robin Koskey, PSRC's Director of Government Relations and Communications, who briefed the board on federal and state policy updates.

Paul mentioned the Regional Transportation Plan virtual public meeting coming up on November 20, 2025, and introduced the items on the agenda.

### **CONSENT AGENDA**

- a. Approve Minutes of Growth Management Policy Board Meeting held October 2, 2025.

**ACTION: It was moved and seconded (Rolfes/Dunn) to adopt the Consent Agenda. The motion passed.**

**DISCUSSION ITEM: REGIONAL CENTERS REDESIGNATION**

The board reviewed regional growth centers criteria and continued the discussion of redesignation for existing centers. PSRC staff shared drafts of center criteria and certification reports for nine regional growth centers in Everett, Seattle, and Tacoma. In early 2026, staff will ask the board to make a recommendation to the Executive Board on redesignating regional centers.

**DISCUSSION ITEM: 2025 HOUSING MONITORING UPDATE**

The Growth Management Policy Board provided feedback on how housing monitoring data can help jurisdictions meet new state housing requirements. PSRC staff shared new metrics and analysis for 2025 on housing affordability, the production of emergency housing, and permanent supportive housing. The housing policy landscape is evolving at all levels of government and PSRC will continue to monitor and report findings to the board.

**DISCUSSION ITEM: REGIONAL ECONOMIC STRATEGY UPDATE**

PSRC staff provided a brief update on the development of the Regional Economic Strategy, including an overview of the draft process and in particular the strengths, weaknesses, opportunities and threats (SWOT) analysis. The inputs from the SWOT analysis in tandem with the Engagement Hub responses will inform the update to the Regional Economic Strategy. In December, the Economic Development District Board will prioritize strategies and discuss PSRC's role in regional economic development.

**Subject: Recommend Certification of Comprehensive Plans for Des Moines**

## IN BRIEF

At its January meeting, the Growth Management Policy Board will be asked to recommend certification of the Des Moines comprehensive plan and staff will present highlights of the overall certification process and comprehensive plan updates.

## RECOMMENDED ACTION

**The Growth Management Policy Board and Transportation Policy Board should recommend that the Executive Board certify that the transportation-related provisions in the following conform to the Growth Management Act and are consistent with the multicounty planning policies and the Regional Transportation Plan:**

- **City of Des Moines 2024 Comprehensive Plan ([link](#))**

The draft certification report is available at the link provided for the board's review.

## DISCUSSION

A major emphasis of the Washington State Growth Management Act (GMA) is the need to coordinate local, regional and state planning efforts. Within the central Puget Sound region, local governments and the Puget Sound Regional Council (PSRC) have worked together to develop an overall process for reviewing local, countywide, regional and transit agency policies and plans for compatibility and consistency.

Consistent with [PSRC's plan review process](#), PSRC staff provided comments on the

draft plan and now recommends certification of the following adopted comprehensive plan:

- **Des Moines** adopted its 2024 comprehensive plan update on September 25, 2025. PSRC staff provided comments on the draft plan in May and July 2025.

The comprehensive plan was reviewed in accordance with the adopted plan review process using PSRC's [Plan Review Manual](#) and [VISION 2050 consistency tool](#). The plan was found to be substantially consistent with VISION 2050 (the multicounty planning policies) and the Regional Transportation Plan and to conform to transportation planning requirements in the Growth Management Act. PSRC staff coordinated with jurisdictional staff in the review of the plan and the development of the certification report.

The adopted plan review process calls for the Executive Board to take certification action on comprehensive plans on recommendation from the Growth Management and Transportation Policy Boards. Options for Executive Board action are to:

- Certify that the plan is consistent with multicounty planning policies and the Regional Transportation Plan and conforms to Growth Management Act requirements for transportation planning, or
- Conditionally certify that the plan addresses most provisions of regional plans and policies and the Growth Management Act, with a requirement that a limited set of outstanding issues be addressed prior to full certification, or
- Do not certify.

Based on previous board direction, jurisdictions with plans that are certified or conditionally certified are then eligible to apply for PSRC funding or proceed with any project submitted into the Regional Transportation Improvement Program.

## Comprehensive Plan Highlights

Over the last few years, each of the region's 82 cities and towns and four counties worked to update their comprehensive plans. The Growth Management Policy Board spent most of 2025 reviewing comprehensive plans for certification action. With most plans now adopted and certified, board members requested a summary of highlights from the 2024 comprehensive plan updates. PSRC staff will provide a report about the culmination of plan certifications at the January meeting.

PSRC staff surveyed board members and local governments to capture successes and challenges from 2024 comprehensive plan updates, feedback on the PSRC certification process, and any additional research or planning resources needed in the future. Staff will provide initial findings from the surveys at the meeting.

## NEXT STEPS

The Executive Board will consider the board's recommendation at its February meeting. Additional certifications will be brought forward for consideration at future board

meetings.

### **IN BRIEF**

In November, the Growth Management Policy Board began previewing criteria and certification reports for regional centers. This month, the board will be asked to continue to preview the next batch of regional growth center criteria and certification reports. The board will be asked to make a recommendation to the Executive Board on redesignating existing regional growth centers at a future meeting.

### **DISCUSSION**

Centers are the hallmark of VISION 2050 and the Regional Growth Strategy. The region's 30 regional growth centers and 10 manufacturing/industrial centers are hubs for the Puget Sound region's most significant businesses, major cultural facilities, and transportation connections. They guide regional growth allocations, advance local planning, inform transit service planning, and represent priority areas for PSRC's federal transportation funding.

In 2018, following extensive review by GMPB, the Executive Board adopted the [Regional Centers Framework](#), which defines standards for the designation of regional and countywide centers. The Regional Centers Framework directed review of centers in 2025 and every five years thereafter. At the first review in 2025, existing regional centers are expected to fully meet eligibility and designation criteria.

A general schedule of the centers review and redesignation process is provided below:

November 2025	Review policy topics; review criteria and certification reports for existing centers

### Redesignation Review

Over time, regional centers have been designated through different processes, and some existing centers are not meeting planning or growth expectations today. Recognizing the variation among centers, a key objective of the Regional Centers Framework is to have more consistent requirements between new and existing centers. However, the monitoring report found that several existing regional centers continue to not fully meet the designation criteria. Some are not growing, don't meet density expectations, or lack regional transit connections. Others lack detailed and up-to-date local planning.

The board has had several conversations about how to approach centers that do not fully meet criteria. Recognizing that planning for a center is an ongoing process, the board has discussed providing flexibility for required subarea plans, especially in light of the demands of recent state-level planning mandates. The board also discussed the need to balance expectations between high-growth centers and incentivizing growth for centers that are growing slowly. The board has also discussed the importance of walkable centers to successfully attract growth and development, while recognizing that the location of some transit investments may warrant exceptions to maximum size criteria.

At the January board meeting, the board will be asked to continue the discussion of regional growth centers, including previewing reports for some centers that do not fully meet the designation criteria. With the draft criteria reports (see below) staff may recommend:

- Redesignating centers that are substantially meeting the criteria with comments

- to guide additional work that should continue prior to the next review.
- Redesignating centers with conditions that require additional specific work to address gaps in meeting the criteria.
- Where a center is below the threshold for multiple criteria and not showing signs of growth, potential redesignation from a regional center to countywide center.

Much like with the review of comprehensive plans, including redesignation conditions establishes responsibility for the jurisdiction to complete a limited amount of additional work in a set time period. Changing a regional center to a countywide center can create better alignment with other similar centers.

### Criteria and Certification Reports

PSRC has prepared draft criteria and certification reports that provide a brief summary of each center and its subarea plan. Information and analysis of the centers are presented through two key reporting tools:

- **Criteria reports** provide a preliminary recommendation on redesignation, along with any conditions or comments. The reports provide a general overview of the regional center and summarize how each center meets designation criteria. Reports also include any additional context or supporting information provided by the jurisdiction following meetings with PSRC staff.
- **Certification reports** evaluate the most recent center subarea plans and assess alignment with the VISION 2050 consistency tools for [manufacturing/industrial center](#) and [regional growth center](#) plans.

Many centers are performing well and meet most of the criteria. PSRC staff have been meeting with jurisdictions to review draft criteria reports, discuss successes and barriers to development and upcoming local work. Draft criteria and certification reports for the following centers are listed below for the board's review. Reports with recommended conditions reflect discussions with jurisdiction staff on work to be completed by a specified date or other comments for future implementation.

The board is currently focused on reviewing regional growth centers, and the reports will be provided at meetings in batches. The January meeting will focus on the second batch of regional growth centers, and staff expect to bring the remaining nine regional growth centers for discussion in February. Review of manufacturing/industrial centers will follow in subsequent months.

The board will be asked to make a recommendation on redesignating regional growth centers as a group in February or March 2026, after the board has had an opportunity to review the full set of recommendations. Do the draft reports align with the board's direction? Does the board have any questions regarding the draft reports?

Subject: **Draft Supplemental Biennial Budget and Work Program (FY2026-2027)**

### IN BRIEF

At its January meeting, the Growth Management Policy Board will be given information on the Draft Supplemental Biennial Budget and Work Program FY2026-2027.

### BACKGROUND

PSRC's Biennial Budget and Work Program was adopted in May 2025 and covers July 1, 2025 through June 30, 2027.

The proposed supplemental budget reflects revenues and expenditure of \$45,618,000, including approximately \$3.5 million in increased carryover grants from the previous biennium that have been added since adoption in May 2025. As a reminder, grants are awarded on a reimbursement basis and are earned only after completion of the work. A full draft budget is available online at <https://www.psrc.org/about/budget>.

Throughout the month of January, the draft supplemental budget information will be provided to the Executive Board, Economic Development Board, Growth Management Policy Board, Transportation Policy Board, and the Regional Staff Committee. PSRC staff will bring any comments received to the February 26 meeting of the Operations Committee. In March the Operations Committee will be asked to recommend approval of the budget by the Executive Board and in April, the Executive Board will recommend the budget for adoption by the General Assembly to be held May 28, 2026.
