### Welcome and Introductions

Jean Kim, PSRC, welcomed everyone at 9:30 a.m. and took a roll call of the membership in attendance.

### Approval of Meeting Summary

The October 15, 2025 meeting summary was approved as presented.

### Discussion: 2025-2027 WSDOT Consolidated Grant Regional Priority Ranking Process Debrief

Erin Hogan, PSRC, provided an overview of the regional priority ranking process conducted for the 2025-27 Consolidated Grant program in 2024. Erin reviewed the region's priority ranking allocation process and shared the list of factors used for staff assessment and additional considerations used for CMAC deliberation. Jean Kim, PSRC, presented the 2025-27 biennium award results and facilitated a debrief discussion. Members identified several topics for consideration in the 2026 process:

- Performance Measures and Target Factor: potential measures tailored to project types (e.g., vehicle replacement)
- Equitable Engagement and Communications Factor: potential clarification and refinement for training and PSRC assessment
- Eligibility and competitiveness of microtransit projects within the process
- Alignment between operation/expansion projects and relevant capital projects for final award and ranking decisions

Matthew Cramer, WSDOT, presented the statewide Consolidated Grant process and award results. CMAC members asked questions and provided feedback.

The committee agreed to incorporate the refinements into the draft Coordinated Mobility Plan, which will be released for public comment in mid-December.
