Topic 1:

Have you worked with communities that have limited capacity? How have you navigated this challenge to make the engagement experience more meaningful and collaborative?

- Coordinate with other agencies that work alongside communities with limited capacity to share information before overburdening communities by re-asking questions
- Engage with communities by attending events you were invited to; work to build relationships that extend beyond the transactional
- Reach out and connect on a personal level with staff and community members
- When opportunities for funding arise, share information and resources, and/or contribute to events and partnerships
- Approach Tribes at their elder council meetings and introduce yourselves
- Maintain regular email and text relationships
- These partnerships require time and continuous effort to be meaningful and genuine

Topic 2:

PSRC will engage with Tribes on the development of the Regional Open Space Conservation Plan in 2026. Do you have any suggestions for improving engagement with Tribes on this topic?

- Engage with the Tribes ready to listen
- Acknowledge the harm caused by the agencies or organizations you are a part of
- Have the Tribes communicated how they prefer to engage or communicate?
- Go into conversations with a mindset of what you can offer, not what just what you can take

Project Tracking Policies

The board was briefed on two potential updates to PSRC's adopted project tracking policies. The purpose of PSRC's project tracking program is to monitor the delivery of projects awarded PSRC's federal funds. PSRC's Regional Project Evaluation Committee (RPEC) has been discussing two revisions to the adopted tracking policies. These include modifying the limit for administrative transfer of PSRC funds between phases of a project and consideration of increased cost estimates during annual supplemental funding awards and application of increased federal shares. IN BRIEF

PSRC staff will brief the Equity Advisory Committee on current state and federal budget and policy developments and provide an update on the PSRC 2026 recommendations to the Washington State Legislature.

DISCUSSION

Federal

PSRC continues to monitor the impact of proposed legislation, rule-making, and federal funding directives for our region, including progress on appropriations, Contiuum of Care and surface transportation reauthorization. We are also keeping in close contact with members of our federal delegation to relay consequences of actions at the federal level to local governments and our region.

State

The Washington State Legislature began their 60-day, short legislative session on January 12, 2026, and PSRC is tracking legislative proposals and the Legislature's response to Governor Ferguson's proposed supplemental budget.

PSRC 2026 Recommendations to the Washington State Legislature

On an annual basis, the Executive Board adopts recommendations to the Legislature to support progress on adopted regional plans and policies. PSRC staff discussed the recommendations and asked for feedback from the EAC in November. An update will

be provided on the final 2026 recommendations as adopted by the Executive Board in December of 2025.

Recommendations to the 2026 State Legislature



Puget Sound Regional Council

The Puget Sound Regional Council (PSRC) seeks to address regional growth through policies that advance affordable housing, connected transportation, sustainability and a strong economy.

We acknowledge the challenging economic conditions facing our state and region, compounded by federal-level uncertainty and declining state revenue. PSRC values the Legislature's continued partnership and commitment to working with local governments and elected officials to implement shared priorities.



Equity Advisory Committee

Keep the Region Moving Safely

A reliable, efficient transportation system is critical infrastructure to build a thriving region where people are connected to homes and jobs. All transportation investments should be planned and implemented with emphasis on safety to reduce deaths and serious injuries on the region's roadways.

- Sustain transportation investments to fully fund maintenance and preservation, ensure projects of regional significance are built, and provide tools to address local funding needs, the largest revenue gap for the region.
- Develop an alternative to the state gas tax through an equitable road usage charge or highway use fee system.
- Continue capital and workforce investment in the Washington State Ferries system to ensure reliable service.

Increase Housing Choices and Affordability

Housing affordability continues to be a top concern of residents and local elected officials in communities in the region. We need to build 620,000 more homes by 2044 and 50% of these homes need to be affordable to people earning less than half of the Area Median Income.

- Invest in operating and capital subsidies to create affordable homes to meet local needs and create homeownership opportunities for Black, Indigenous, and people of color (BIPOC) households.
- Adopt policies to increase housing supply in coordination with local governments to ensure practical and effective implementation.
- Establish the Housing Futures Center at the University of Washington to provide timely analysis and data-driven research for policymakers to address urgent housing needs in our state.

Significantly Reduce Greenhouse Gas Emissions

Enact legislation to respond to the urgent environmental, health, economic and equity threats of climate change through:

- Transit-focused land use.
- Multimodal transportation choices.
- Pricing the transportation system.
- Decarbonization of the transportation system, including freight, transit, ferries, passenger vehicles and fuels.

Sustain a Strong Economy

- Invest in workforce development programs to support workers and meet the needs of employers and a growing economy, including electrification of the transportation system.
- Commit resources to critical infrastructure to support economic development, including broadband.
- Support clean energy industry technology like Sustainable Aviation Fuel (SAF), offshore wind, fusion, hydrogen, and other emerging technologies.
