### **FTA FIFA World Cup Funding Distribution**

Kelly McGourty, PSRC, led discussion on options to distribute the \$8.5 million in FTA funding to support public transit for FIFA World Cup. The discussion built on previous discussion at the special TOC meeting on April 13, 2026. After transit agency input on the two options presented, the TOC voted unanimously in support of Option 1 with a \$200,000 minimum floor for funding distribution (shown as Option 1, “Adjusted Distribution Amount” in the presentation).
