

Why is PSRC's plan review important?

- Advances regional policy goals set forth in VISION 2050
- Helps coordinate individual plans to work collectively
- Encourages best practices in local planning
- Required by state law (CPPs, comp plans, transit plans) or regional policy (regional centers)
- Comprehensive plan certification is required to be eligible for PSRC's federal transportation funding



Planning Framework



- State law requires PSRC to review and certify countywide planning policies and local comprehensive plans
- RCW 81.104.040 requires PSRC to review Sound Transit's long-range system plans
- PSRC's Policy & Plan Review Process (2003) calls for review and certification of regional center plans
- 2017 MOU between PSRC & transit agencies calls for review of transit plans





VISION 2050 Consistency Tools

Tools should be used throughout the planning process

VISION Consistency Tool for Local Comprehensive Plans

Note: The tool shown here is for illustrative purposes. To fill out the tool, visit www.psrc.org/our-work/plan-review.

This tool is intended to help cities and counties integrate VISION 2050 into their local comprehensive plans. VISION 2050's multicounty planning policies serve as the adopted regional guidelines and principles required in state law to guide both regional and local planning. The tool also identifies transportation planning requirements of the Growth Management Act (GMA). The tool may be used at various times in the local planning process:

Plan Update Scoping: Use checklist items as guidance for scoping the extent of plan element updates. New or expanded issue areas in VISION 2050 are identified to support this process.

Draft Plan Review: Submit draft plans to PSRC prior to Planning Commission and Council review. Completing and submitting this tool and providing early drafts to PSRC help identify potential consistency issues early in the process.

Cortification Review: Along with the adopted plan, the tool will assist in PSRC's review of the plan. Demonstrating inclusion of the necessary information in the checklist helps facilitate certification. Note: The PSRC Executive Board is the final decision-making body for plan certification.

Standard for Review

In accordance with state law, PSRC reviews comprehensive plans in the 4-county region

Plans must conform to:

- 1.) GMA transportation-related planning requirements
- 2.) Regional Transportation Plan
- 3.) Regional guidelines and principles (VISION 2050 MPPs)

Certification is a requirement for funding requests or projects submitted to the Regional Transportation Improvement Plan

Possible Certification Outcomes

PSRC's Executive Board is the final decision-making body for plan certification.

Certification Focus Areas (Comp Plans)

GMA transportation-related requirements

- Land use assumptions and travel demand forecasts are consistent with each other and growth targets

- Plan for transportation financing and investments

Consistency with Regional Transportation Plans

- Transportation project lists, including financing strategies
- Transportation modeling based on shared regional growth assumptions

Consistency with VISION 2050 MPPs

- Regional Growth Strategy
- Climate change and air quality through reduction of transportation-related GHG emissions and pollution
- Equitable transit-oriented development (TOD)
- Housing supply and choices near transit and job centers
