#### **Welcome and Introductions**

Peter Heffernan, Chair, welcomed everyone at 10:00 a.m. Gil Cerise, PSRC took a roll call and confirmed the members and alternates present.

## **Approval of Meeting Summary**

## **Transportation Policy Board Debrief**

## **Action: King County Metro Redistribution Request**

Sarah Gutschow, PSRC, reviewed the King County Metro funding redistribution requests which were:

- Redistributing \$30,748,517 in Seattle-Tacoma Everett (STE) 2022 5307 Earned Share funds and \$5,298,616 in 2022 5307 Preservation Set-aside funds between projects
- Redistributing \$7,581,876 in STE 2022 FTA 5337 HIMB funds between projects

The committee agreed to vote once on both the redistribution requests and the allocation request (item below) after Sarah reviewed the allocation request and any committee questions or discussion.

## **Action: King County Metro Funding Allocation Request**

Sarah reviewed the King County Metro funding allocation request to allocate \$9,501,611 in previously unprogrammed STE 2022 5337 HIFG funds to five projects. She noted this would have to be released for public comment once approved by the Transportation Policy Board. The committee discussed this request and then included this in the vote for approval of the two redistribution requests (item above). The committee then voted unanimously to approve both the redistribution requests and the allocation request for recommendation by the Transportation Policy Board.

Jean Kim, PSRC, provided an overview of comments received on the Coordinated Mobility Plan from PSRC's Equity Advisory Committee meeting in March. Gil then went over the topics on the draft table in more detail and the committee discussed and provided input and suggestions.

## **Transit Coordination Grants**

Funded by: Climate Commitment Act ESSB 5975 (spending bill)

Funds available: \$1 million

Fund Availability Date: July 1, 2022 – June 30, 2023

Vulnerable Populations living within Overburdened Communities Goals: Minimum 35%/Goal 40%

Sponsor: <u>Jill Nordstrom</u> Staff Contact: <u>Evan Olsen</u>

## **Proviso language**

<u>ESSB 5975 Sec 211(4) - \$1,000,000</u> of the climate transit programs account—state appropriation is provided solely for newly selected transit coordination grants. The department shall give priority to grant proposals that promote the formation of joint partnerships between transit agencies or merge service delivery across entities.

#### **Major Tasks**

- 1. Identify eligible entities
- 2. Set up application funding cycle
- 3. Determine and vet CCA data methodologies
- 4. Determine and vet funding solution/ cycle
- 5. Finalize temporary solutions in 2023 GPAC process.

#### Issues to be addressed

- Should we assume there was intent to fund the old program? Puget Sound Coordination Grants technically no longer exist in RCW.
- How do we incorporate new focus/language?

**SUBJECT: Update on the Regional Transportation Plan** 

#### **IN BRIEF**

At the April meeting, PSRC staff will continue discussion on potential transit-related work program items arising from the Regional Transportation Plan (RTP) scheduled for adoption on May 26, 2022.

#### DISCUSSION

At the April meeting, staff will initiate discussion on topics not discussed at the March TOC meeting and continue discussion on other topics. The topics listed below are included in the draft RTP related to transit.

Although the draft RTP is in process of being amended at the board level, and the final document is not scheduled for adoption until May 26, staff would like to solicit transit agency feedback on the following topics:

- Access to transit: this is a thematic element throughout the draft RTP. PSRC developed tools and resources associated with this topic in the 2013-2018 timeframe. Transit agencies have continued to work together and with local jurisdictions and the state to advance this work. We are interested in hearing from transit agency perspectives how this topic can continue to be advanced in the future. Some TOC comments on additional topics to consider at the March meeting could fall under the access to transit topic.
- Transit plan coordination and review: TOC began this discussion at the March TOC meeting. Staff would like to continue the discussion with a potential focus on co-creating common understanding around PSRC role associated with some of the higher priority plans without a current process in place. The topic of transit ridership modeling coordination identified in the March meeting could be included within this work program area. See attachment A for updated draft table of transit agency plans.

- 2030 transit network: Although also previously discussed in March 2022, staff
  would like to do a roundtable that assesses transit agency readiness to provide a
  2030 transit network that is consistent with the <u>Regional Capacity Project list</u> in
  the draft RTP.
- Mobility needs from Coordinated Mobility Plan: Staff conducted extensive outreach to people with disabilities, people with low-incomes, older adults, youth, and other people with mobility challenges to develop the draft Coordinated Mobility Plan incorporated as part of the draft RTP. Most of mobility needs identified in this document were those associated with the passenger experience on transit agency services. Continued discussion at the PSRC Equity Advisory Committee and the board has continued to emphasize work needed to address mobility needs of the populations covered in this plan. Staff would like to initiate discussion on how this information can be used by transit agencies to address mobility needs included in the document.

In addition to the topics listed above, TOC members identified other topics for potential inclusion as future discussion items including displacement, and challenges associated with transit fleet planning.

Staff are seeking initial TOC feedback on these topics through short discussion on each item at the April 27 meeting. Please come to the meeting prepared to provide feedback on these topics. As time allows, we can talk about additional topics of interest to transit agencies.

**SUBJECT:** 2022 Transit Integration Report Introduction

#### IN BRIEF

At the April 27 meeting, PSRC staff will initiate discussion of the 2022 Transit Integration Report. Staff will seek feedback on a draft schedule, approach for developing the report, and an initial list of story ideas.

#### **BACKGROUND**

Each year PSRC creates a Transit Integration Report to document public transportation coordination in and between counties in the central Puget Sound region. This report is shared with WSDOT to fulfill RCW 35.58.2796(2)(a), which calls for a report on coordination among the counties in this region, specifically in the areas of:

- Integrating marketing efforts,
- Aligning fare structures,
- Integrating service planning,
- Coordinating long-range planning, including capital projects planning and implementation,
- Integrating other administrative functions and internal business processes as appropriate, and
- Integrating certain customer-focused tools and initiatives.

Additionally, the report has served to meet the reporting requirements of the transit coordination grant program (RCW 47.66.110).

#### **DISCUSSION**

Based on feedback from TOC, the Transportation Policy Board (TPB) Transit Caucus, and internal PSRC debriefing of the 2021 report process, PSRC has developed the following draft schedule for 2022 and started brainstorming potential report approaches and story ideas. PSRC is asking for feedback from the TOC on these plans.

## Schedule

 Introduce Topic – April TOC, May TPB Transit Caucus, April/May committee meetings for SNTC, TDM, etc.

- Outline Development May
- Story Drafting June August
- PSRC Internal and TOC Review September
- Report Production October
- Transportation Policy Board Review & Submission to WSDOT November

Note: Per RCW 35.58.2796(2)(a) WSDOT must make the report available to the transportation committees of the legislature and the municipalities within the region by December 1<sup>st</sup> of each year.

#### Draft Approach and Process

- Provide some shorter updates on previously reported topics and a few new feature stories
- Explore leveraging Mobility Partnership Group sub-committees (closely aligned with TIR reporting areas)—report on work programs, priorities, progress
- Share a complete first draft with TOC members and allow an additional week for review turnaround.

#### Potential Story Ideas

- 2022 rollout of next generation ORCA
- East Link Connections and/or other planning for 2023 openings
- Progress on Hilltop Tacoma Link Extension—maybe spotlight equitable, community-led TOD work being done in advance of 2023 opening
- Update HCT project timeline from 2021 report
- One-Call/One-Click (King County Mobility Coalition) starting in 2022—included in 2021 report; provide short progress update?
- · Coordinated operator recruitment/addressing workforce shortages.
- Changes to fare policy/enforcement approaches and evaluation of consistency; Farefree Youth implementation
- How can we integrate/consider equity in TIR?
- Impacts of Move Ahead Washington and Bipartisan Infrastructure Law/Infrastructure Investment and Jobs Act
- Short update on new work coming out of RTP?
