## Bipartisan Infrastructure Law (BIL) — more funding for existing programs and a slew of new programs


### More infrastructure funding than ever before...

- \$1.2 Trillion over 5 years for all types of infrastructure
- \$550 Billion in new spending
- \$567 Billion for TRANSPORTATION spending
  - FAST Act baseline = \$293.4 Billion
  - **new** spending = \$274.1 Billion

### ...and many new transportation programs to be created.





### Understanding the 2021 infrastructure law

The \$1.2 trillion Infrastructure Investment and Jobs Act (IIJA), passed in November 2021, now governs all federal transportation policy and funding through 2026. (You'll frequently hear "infrastructure law" or "bipartisan infrastructure deal" as shorthand for the IIJA.) This mammoth bill was the final product of congressional negotiations in 2020 and 2021 over long-term transportation proposals, as well as a standalone infrastructure bill. The final product turned out to be an amalgamation of both

### **Highways & Bridges — STP & TA Programs**

### **Program Purpose:**

 To promote flexibility in State and local transportation decisions and provides flexible funding to best address State and local transportation needs.

### **Program Changes:**

- STBG /STP Adds several new types of eligible projects, including EV charging infrastructure, protective features to enhance resilience, and wildlife crossing projects
- TAP significant increase in available funding (is now 10% of STBG total is set-aside)
- Creates suballocation for urbanized areas < 50K</li>

### **Highways & Bridges — CMAQ**

#### **Program Purpose:**

 To provide a flexible funding source to state and local governments for transportation projects and programs to help meet the requirements of the Clean Air Act.

### **Program Changes:**

- Adds new eligibilities for:
  - shared micromobility (e.g., bikeshare, shared e-scooters)
  - purchase of diesel replacements
  - purchase of medium/heavy-duty zero emission vehicles and related charging equipment
- Allows states to spend up to 10% on certain lock/dam projects

### **Highways & Bridges — NHPP**

#### **Program Purpose:**

- To provide support for the condition and performance of the NHS
- To provide support for the construction of new facilities on the NHS
- To ensure that investments support progress toward the achievement of performance targets
- NEW To provide support for activities to increase the resiliency of the NHS to mitigate the cost of damages from sea level rise, extreme weather events, flooding, wildfires, or other natural disasters

### Adds new eligible projects including:

- Undergrounding public utility infrastructure carried out in conjunction with an otherwise eligible project
- Resiliency improvements including protective features on the NHS
- Activities to protect NHS segments from cybersecurity threats

### **Highways & Bridges — HSIP**

#### **Program Purpose:**

 To achieve a significant reduction in traffic fatalities and serious injuries on all public roads, including non-State-owned public roads and roads on tribal land

### **Program Changes:**

- Restores ability to fund certain non-infrastructure activities such as educational campaigns
- Now includes roundabouts, ped/bike traffic control devices, traffic calming / speed reduction measures, and ped/bike/vehicle separation as eligible projects
- Requires states to conduct a vulnerable road user safety assessment

### **Highways & Bridges — NHFP**

#### **Program Purpose:**

 To improve the efficient movement of freight on the National Highway Freight Network

### **Program Changes:**

- Increases amount a state may obligate to freight intermodal or freight rail projects to 30% (from 10%)
- New eligibility for lock / dam modernization and marine highway corridor projects
- Increases CRFC miles from 150 to 300 and CUFC from 75 to 150

### New formula program— Bridge Formula Program

#### **Program Purpose:**

 New program that provides funds for projects designed to replace, rehabilitate, preserve, protect, and construct highway bridges.

- 15% set-aside for off-system bridges
- 100% federal share for locally-owned off-system bridges (including tribes)

### **New formula program – Carbon Reduction Program**

#### **Program Purpose:**

 New program that provides funds for projects designed to reduce transportation emissions, defined as carbon dioxide (CO2) emissions from on-road highway sources.

#### **Key Points:**

Similar eligibilities to CMAQ Program

 States and their MPOs will need to develop a carbon reduction strategy within 2 years, and update it every 4 years

### New formula program— NEVI Program

#### **Program Purpose:**

 New program that provides funds to states to strategically deploy electric vehicle (EV) charging infrastructure and to establish an interconnected network to facilitate data collection, access, and reliability

- Each state is required to submit an EV Infrastructure Deployment Plan that describes how the State intends to use its apportioned NEVI Formula Program funds by August 1, 2022
- Projects must be on designated corridors

## New discretionary program— Bridge Investment Program

### **Program Purpose:**

 To improve bridge and culvert condition, safety, efficiency, and reliability

### **Key Points:**

 Competitive program on top of the new Bridge Formula Program

 Allows multi-year grant agreements to fund large projects by making it possible to take a project through pre-construction activities and into construction.

## New discretionary program— Charging & Fueling Infrastructure Program

#### **Program Purpose:**

 Provides grants to install EV charging and alternative fuel in locations on public roads, schools, parks, and in publicly accessible parking facilities

### **Key Points:**

- Grants will prioritize rural areas, low-and moderate-income neighborhoods, and communities with low ratios of private parking or high ratios of multi-unit dwellings
- Eligible projects include acquisition and installation of publicly accessible EV charging or alternative fueling infrastructure, operating assistance, and acquisition / installation of traffic control devices

### New discretionary program— Congestion Relief Program

#### **Program Purpose:**

 To advance innovative, integrated, and multimodal solutions to reduce congestion and the related economic and environmental costs in the most congested metropolitan areas with population over 1 million.

- Eligible projects include:
  - integrated congestion management systems
  - systems that implement or enforce high occupancy vehicle toll lanes or pricing strategies
  - incentive programs that encourage carpooling, nonhighway travel during peak periods, or travel during nonpeak periods.



Otherwise, changes to these existing formula programs requirements are minimal:

- Urbanized Area Formula Grants 5307
  - Must now allocate not less than 0.75 percent to safety related projects.
- Enhanced Mobility of Seniors & Individuals with Disabilities – 5310
  - No changes
- State of Good Repair Grants 5337
  - Adds new discretionary rail vehicle replacement program
- Buses and Bus Facilities Program 5339
  - No changes

### Existing discretionary program — TOD Pilot Program

### **Program Purpose:**

 To integrate land use and transportation planning in new fixed guideway and core capacity transit project corridors.

- Permits federal financing for site-specific planning now, too (previously only comprehensive planning was eligible).
- Projects must foster multimodal connectivity and accessibility, and enable mixed-use development near transit stations
- FTA is "reviewing opportunities to prioritize TOD planning grants in areas of high incidence rates of homelessness."





#### The unique entity identifier used in SAM.gov has changed.

On **April 4, 2022**, the unique entity identifier used across the federal government changed from the DUNS Number to the Unique Entity ID (generated by SAM.gov).

- The Unique Entity ID is a 12-character alphanumeric ID assigned to an entity by SAM.gov.
- As part of this transition, the DUNS Number has been removed from SAM.gov.
- Entity registration, searching, and data entry in SAM.gov now require use of the new Unique Entity ID.
