

- Lift-equipped vehicles






# NSC Transportation by the numbers



- Fleet of 12 cutaway vans, most are lift-equipped
- Two passenger minivans
- Staff of 14 drivers and dispatchers
- Average 1,445 one-way trips per month in 2022
- Typically serve 160 unduplicated riders each month
