It will also fund six safety plans for the cities of Burien, Everett, Kent, Redmond, Tukwila and Pierce County. PSRC expects to bring an action to the Operations Committee related to adding the grant award to the budget. The committee will receive further details at that meeting. Members discussed grant funding for ports and notifying members when further funding is available.

Subject: Approve Increased Contract Authority for Low Voltage Installation

IN BRIEF

Authorization by the Executive Board is required for the Executive Director to enter a contract in excess of \$10,000 per year. In January, the Executive Board approved authorization for low voltage cabling in an amount not to exceed \$121,000 for installation in PSRC's new office space. After receiving four estimates, staff is requesting increased authority in an amount not to exceed \$185,000.

RECOMMENDED ACTION

Recommend the Executive Board to authorize the Executive Director to enter one or more contracts for low voltage installation in an amount not to exceed \$185,000.

BUDGET IMPACT

The adopted Biennial Budget and Work Program includes sufficient funds within the budget for the down payment needed to secure the purchase of the low voltage cabling for PSRC's new office space. The remainder of the expenditure will be reflected in the biennial budget and work program proposal for Fiscal Years 2024-2025.

DISCUSSION

On July 28, 2022, the Executive board authorized the Executive Director to execute a lease for new office space at 1201 3rd Avenue in downtown Seattle, effective January 1, 2024. The lease, as executed, requires the landlord to pay for the entirety of the construction-related tenant improvements. PSRC is responsible for certain improvements, such as cabling, required to ensure access to internet, computer networks, phones, and web-streaming.

In February 2023, the Executive Board approved authorization for low voltage cabling (or IT cabling) in an amount not to exceed \$121,000. Staff reached out to vendors who successfully bid for the state's contracts for IT cabling and received four estimates ranging from \$150,000 to \$390,000. Staff selected the vendor with the lowest cost estimate and is seeking contract authority with some built-in contingency.

IN BRIEF

On Thursday, March 23, 2023, the Operations Committee will be asked to recommend to the Executive Board the Fiscal Years 2024-2025 Biennial Budget and Work Program for adoption by the General Assembly on April 29, 2023.

Additional information on dues options will be sent to Operations Committee members to facilitate the discussion and to finalize the budget proposal.

An April approval by the Executive Board is needed to stay on schedule for adoption at the May 25th General Assembly.

RECOMMENDED ACTIONS

- 1. Recommend that the Executive Board approve the Proposed FY 2024-2025 Biennial Budget and Work Program and recommend adoption by the General Assembly on May 25, 2023.
- Recommend that the General Assembly adopt Resolution PSRC-A-2023-01 authorizing the submittal of the adopted Fiscal Year 2024-2025 Biennial Budget and Work Program.

BUDGET IMPACT

The proposed FY 2024-2025 Biennial Budget and Work Program of \$32.0 million is based on revenue and expense assumptions illustrated in Tables 1 through 7, beginning on page 20 of the Draft FY2024-2025 Biennial Budget and Work Program Document.

BACKGROUND

The Puget Sound Regional Council is a federally designated Metropolitan Planning Organization, the state designated Regional Transportation Planning Organization for the four-county area, and has specific responsibilities under the Infrastructure Investment and Jobs (IIJA) Act, Fixing America's Surface Transportation (FAST) Act, Clean Air Act (CAA), the state Growth Management Act (GMA), the Economic Development Act (EDA), and the Interlocal Agreement approved by PSRC members.

PSRC is funded through a combination of federal and state grants and local funds. The federal grants traditionally make up nearly 80 percent of the funding, while state grants contribute about 5 percent. Local funds provide approximately 15 percent and are used to match the state and federal grants and fund work not covered by federal and state grants.

PSRC's major activities in the FY 2024-2025 Budget and Work Program will build on and enhance efforts carried forward from Fiscal Years 2022-2023, focusing on meeting mandates and continuing to provide essential services to members. The budget contains the following elements: Planning Management, Regional Growth Planning, Transportation Planning, Economic Development, Data, Council Support, Communications, and Administrative Services.

The Operations Committee, which has primary responsibility for developing the annual Budget and Work Program, began work on the budget in September with a review of key dates. In October, the committee reviewed the revenue and expenditure assumptions as well as PSRC's financial policies. The resulting draft of the Budget and Work Program received a final review by the Operations Committee on December 1, 2022.

The Executive Board, Transportation Policy Board, Growth Management Policy Board, and Economic Development District Board were given information on the proposed draft Budget and Work Program in January.

By the conclusion of their March 23rd meeting, the Operations Committee will have finalized a recommended Budget and Work Program for presentation to the Executive Board for approval at their meeting on April 27th, 2023. The action to adopt the Proposed FY 2024-2025 Biennial Budget and Work Program by the General Assembly is contingent upon Executive Board approval in April.

A request is being made to authorize the Executive Director to enter into one or more contracts to include but not limited to space rental, catering, and audio/visual expenses related to the 2023 General Assembly.

RECOMMENDED ACTION

BUDGET IMPACT

Subject: Public Participation Plan

IN BRIEF

PSRC staff have been working with the Equity Advisory Committee to update the Public Participation Plan. A draft version is being reviewed by PSRC boards this month with the goal of releasing the plan for public comment from March 23 to May 8, 2023.

DISCUSSION

The Puget Sound Regional Council maintains a Public Participation Plan to establish consistent procedures to ensure people have reasonable opportunities to be involved in the regional planning process and to provide examples of the types of tools and techniques the agency may use to communicate with the public. Public Participation Plans are a federal requirement for Metropolitan Planning Organizations. PSRC's Public Participation Plan was last updated in 2018.

Staff engaged the Equity Advisory Committee to update the Plan's goals and strategies. In addition, staff incorporated suggested changes from the Federal Highway Administration and the Federal Transit Administration.

The new draft Public Participation Plan has an enhanced focus on equity, updated goals, desired outcomes and guiding principles, as well as a suite of new techniques and tools for engagement. Past versions of the Public Participation Plan have been focused on the Regional Transportation Plan and the Regional Transportation Improvement Program since the mandate for the plan is derived from PSRC's MPO planning requirements. The new plan features an expanded emphasis on public participation related to VISION 2050 and the Regional Economic Strategy.

PSRC is planning a youth engagement program (Summer Planning Academy) starting in July 2023 to increase interest in the planning profession.

DISCUSSION

In summer 2023, staff are conducting a youth engagement program called PSRC Summer Planning Academy (SPA). The goals of the structured youth engagement program include:

- Introducing individuals to the planning process and profession at an early age.
- Engaging young people on a regular basis to provide input on PSRC's policies and programs.
- Promoting equity in the region by actively recruiting and engaging youth from diverse backgrounds including Black, Indigenous, and people of color (BIPOC) communities, low-income residents, and people with disabilities.

The program is open to any rising high school student in the region and will take place on four consecutive Fridays beginning July 21, 2023. Each day will introduce students to planning topics in the region, introduce them to panelists and speakers contributing to this work, and include site visits to relevant locations across the four counties.

At the beginning of the audit, we estimated the cost of the audit to be \$48,000 for PSRC and \$10,300 for CPSEDD and actual audit costs will approximate that amount.

Your Next Scheduled Audit

Your next audit is scheduled to be conducted in late 2023 and early 2024 and will cover the following general areas:

- Accountability for public resources (PSRC)
- Financial statement (PSRC and CPSEDD)
- Federal programs (PSRC)

The estimated cost for the next audit based on current rates is \$48,000 for PSRC and \$10,300 for CPSEDD plus travel expenses. This preliminary estimate is provided as a budgeting tool and not a guarantee of final cost.

If expenditures of federal awards are \$750,000 or more in any fiscal year, notify our Office so we can schedule your audit to meet federal Single Audit requirements. Federal awards can include grants, loans, and non-cash assistance like equipment and supplies.

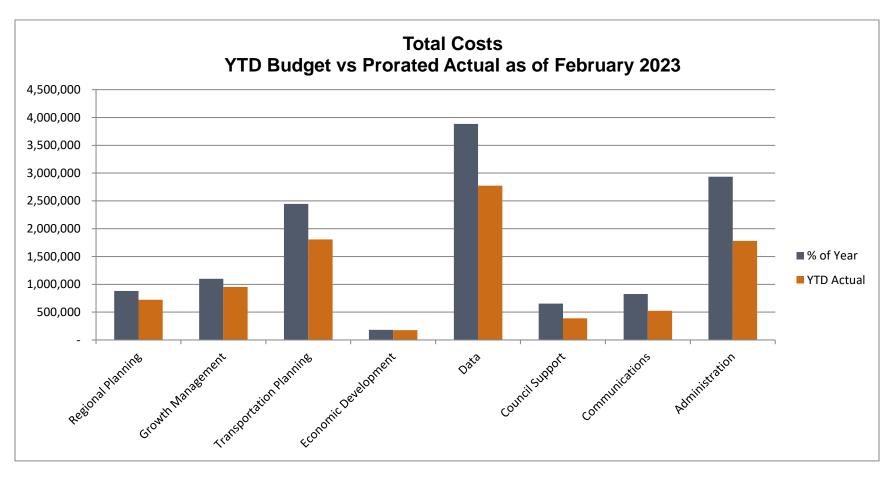
