#### What We Heard - Transit

- Bus stops and transit that connects to schools, community centers, etc.
- Increasing number of rapid transit, bus, light rail, and commuter rail lines
- Free community van / bus options for low-income residents and people with disabilities when buses aren't feasible
- Easy to read transit maps
- Ensure access bus parking areas
- Road diets to slow traffic and increase safety

#### What We Heard - Bike / Ped

- Considering grade and connectivity for wheelchair users, strollers, etc.

- Partnering with programs like safe routes to school in opportunity areas
- Bus stop benches with lighting
- Ensure use of flashing lights with cross walks

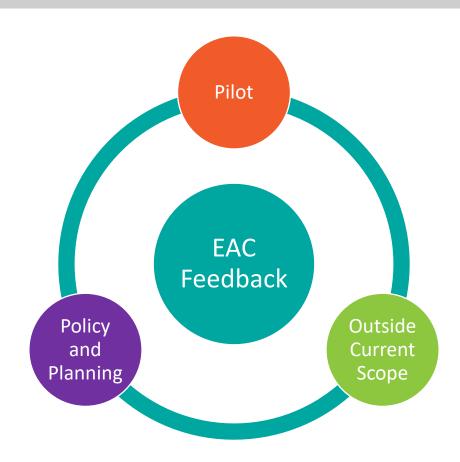


# What We Heard – ADA and Language Access

- Universally understood graphics or icons
- Consider adding an audio tool for those with limited sight

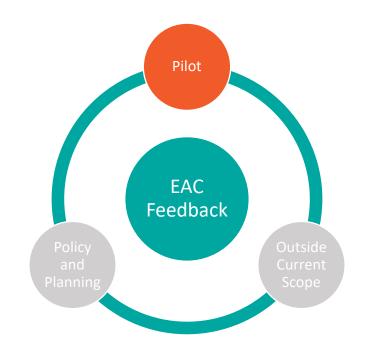


#### What We Heard



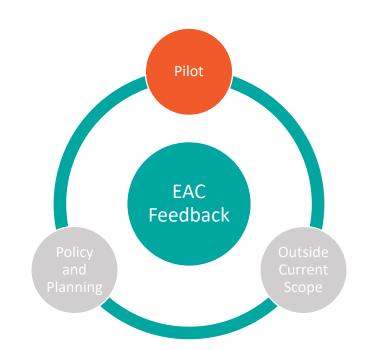


- Consider access to both peak and off-peak transit
- Address resilience of the system (e.g., when the bus doesn't run what are the options)
- Emphasize pedestrian safety
- Address the quality of displacement policies
- Require agencies compensate community members for input



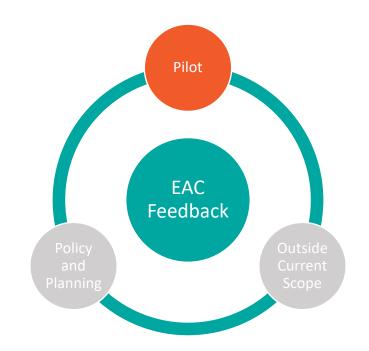


- Consider language access in outreach
- Encourage / require agencies to partner with community on their projects; avoid allowing this to serve as a checkbox experience
- Encourage increased dialogue with marginalized community to learn about needs and build relationships
- Reduce likelihood engagement is an afterthought



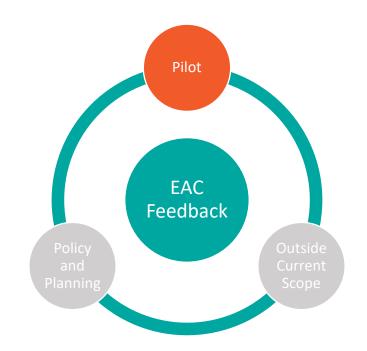


- Weight the equity criterion more, or consider equity as the overall umbrella
- Require sponsors identify the most marginalized group related to the project and describe how it's addressing their needs
- Use the location of marginalized communities in relationship to the project





- Consider the impacts benefits strategies
- Focus on access to destinations and opportunity
- Focus on transit and bike/ped projects

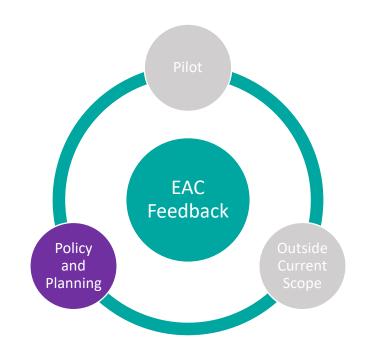




### What We Heard – Policy and Planning

## Comments better suited for PSRC policy and planning work

- Ask agencies to describe how equity was incorporated into their comprehensive plans
- Address the issue of lack of capacity of CBOs (i.e., stop always using the same groups for outreach)
- Require agencies to compare demographics of their staff to population of residents they're attempting to serve

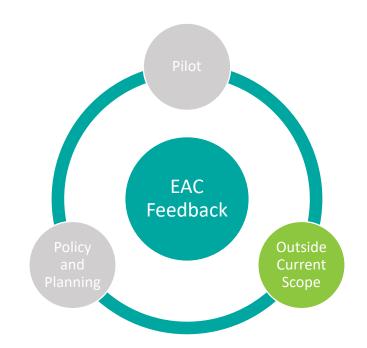




#### What We Heard – Outside Current Scope

# Comments currently outside the scope of the Pilot and require more discussion

- Consider unintended consequences and other elements of the racial equity toolkit
- Report and monitor on outcomes, future community feedback postaward
- Explore how to address income inequality (e.g., area level of income rather than our current thresholds)
- Use models to forecast how project will benefit marginalized users in the future





### **Equity throughout Process vs Equity Criterion**

In addition to the specific **Equity** criterion, other criteria address:

- Support for centers -- supporting densities, access to jobs for all
- Mobility, accessibility and circulation -- supporting active transportation, filling gaps in the system, addressing problems for all
- Safety -- supporting vulnerable users, pedestrian and bicycle safety, reduced reliance on enforcement
- Climate and air quality reduction of emissions, addresses environmental health disparities
- Project readiness



### Equity throughout Process vs Equity Criterion

**OPTION 1** = Improve Equity criterion to the extent possible based on feedback, and increase point values

• Will rework point values for remaining criteria

**OPTION 2** = Reconfigure all criteria to address equity populations

- E.g., "Support for centers" could respond to improving access to jobs for everyone, <u>and</u> specifically improving access to jobs for equity populations
- "Mobility, accessibility and circulation" could address system improvements for everyone, <u>and</u> specifically improvements for equity populations
