Dear PSRC Exec Board;

First, I sincerely apologize I cannot attend your meeting in person as I have a schedule conflict with a Public Disclosure Commission (PDC) case where I am the complainant in 136406 against a respondent *very familiar* to the PSRC so my attention needs to be there to hopefully be the insurance policy to this respondent getting referred to prosecution after failing to file paperwork with the PDC in three separate campaigns. With that, I apologize in part as I am and remain very supportive and very concerned about the future of WSF, and when it comes to the state *transportation* budget, I believe WSF should be funded first.

I am deeply concerned about how we are told every two years, either the Washington State Transportation Commission (WSTC) approves another regressive increase in fares or calamity with no discretion or middle ground. In the latest round, I suggested that seniors - and I'm 41 so not advocating for me - on non-peak days as a special promotion as per the authorizing RCW. I really think we need to do something substantive for our seniors, considering the suffering these fare increases and center those closest to the pain. I also believe the loss of Amy Scarton from WSF was arguably the beginning of the end of WSF as we knew her, and that when Amy Scarton was before you in 2019 it was a final warning from a strong leader sadly not heeded.
