

## **Regional FTA Caucus Meeting Summary**

Date: December 13, 2023 from 10:30 a.m.-11:30 a.m. Location: Online Meeting Only - Zoom Remote Meeting

#### **Welcome and Introductions**

Sarah Gutschow, PSRC, welcomed everyone at 10:30 a.m. and took a roll call and confirmed the members and alternates present.

## **Approval of Meeting Summary**

The summary for the October 11, 2023 Regional FTA Caucus meeting was approved as presented.

#### Discussion: Updates on Delayed FTA and FHWA Obligations

Sarah provided updates on projects that previously or were currently experiencing delays in obligating their regional FTA funds or "flexed" FHWA funds. Sarah said PSRC had recently sent a request for further information about projects that had recently become delayed. This information provided by project sponsors would be reviewed by the Caucus for potential actions at its next meeting.

Chris Eilerman, City of Seattle, then provided a status report on the delayed funds in its Culture Connector streetcar project. This project previously received an extension to March 2024 to obligate delayed flexed FHWA funds, contingent upon the sponsor being able to demonstrate they would have full funding at that time. Chris stated that the City of Seattle did not include local match funding for this project in its 2024 annual budget, so would not be able to obligate federal funds by the extended date. They would therefore be returning the funds to the region. Sarah said that PSRC staff would work with the City of Seattle on next steps for returning the funds.

#### **Discussion: FTA Project Tracking Policies**

In preparation for project selection in 2024, Sarah presented PSRC's proposed updates to the Project Tracking Policies for FTA funds, which were last revised in January 2022. As further detailed in the agenda attachment, since the new equity formula funds were sourced from PSRC's regional FTA funds, the proposed project tracking updates for

these funds would use the default position of following the existing policies and procedures previously applied to projects awarded regional FTA funds.

Caucus members had several questions and alternative proposals for project tracking of the equity formula funds. Since there was not sufficient time to fully address these comments, Sarah and Kelly McGourty, PSRC, said that PSRC would follow up with a survey to committee members after the meeting to gather feedback. The responses would then be presented for further discussion at an extended meeting in January 2024.
