**Subject:** Casino Road Economic Opportunity and Affordable Housing Planning

### **IN BRIEF**

The committee will hear about work to expand economic opportunity, grow organizational capacity, and develop and preserve affordable housing in the Casino Road neighborhood.

## **DISCUSSION**

The Casino Road neighborhood, located in Everett, WA, is a predominantly Latinx community, home to a significant portion of Everett's communities of color and low-income households. This area faces potential displacement risks due to upcoming transit and infrastructure investments, including two planned light rail stations and limited permanently affordable housing. The district encompasses diverse zones including retail, commercial, industrial, and residential areas.

The Local Initiative Support Corporation in Puget Sound (LISC Puget Sound) is committed to supporting economic development initiatives that create equitable opportunities for Black, Indigenous, and People of Color (BIPOC) to participate in and benefit from the economic growth of their neighborhoods. Since 2019, LISC Puget Sound has partnered with Kaiser Permanente to advance health and wealth using a place-based and people-centered approach to district, business, and talent development throughout the Puget Sound region.

Tina Vlasaty, Deputy Director with LISC Puget Sound, will share with the committee work with the Casino Road community to develop an inclusive <u>Economic Agenda</u> and <u>Affordable Housing Workplan</u>.

**Subject:** TOD and Comprehensive Plan Updates

### **IN BRIEF**

Committee members will provide updates on the role of transit-oriented development in 2024 comprehensive plan updates.

## **DISCUSSION**

Each of the region's 82 cities and towns and four counties are updating their local comprehensive plan to continue shaping their community and planning for growth. Comprehensive plans are 20-year plans for growth, are intended to create a meaningful, community-driven vision for local communities, and collectively plan to address interconnected regional issues. Comprehensive plan updates are due December 31, 2024.

Jurisdictions with members on the Regional TOD Committee (Snohomish County, Lynnwood, Redmond, Seattle, Kent, Fife, and Tacoma) will be asked to provide a brief (5 – 10 minute) update on the role of TOD in their 2024 comprehensive plan. Updates may focus on proposed densities and how new or existing transit investments are shaping planning for affordable housing, transit access, or other aspects of the plan.

Other agencies, organizations, and members serving on the committee will also be asked how they are engaged with comprehensive plan updates.
