Transit Operators Committee Meeting Summary

Date: September 25, 2024

Location: Online Meeting Only: Zoom Remote Meeting

Welcome and Introductions

Gil Cerise, PSRC, welcomed everyone at 10:00 a.m. Gil took roll call and confirmed the members and alternates present.

Approval of Meeting Summary

The summary for the July 24, 2024, meeting was approved.

Transportation Policy Board Debrief

Gil Cerise, PSRC, provided a brief overview of the September Transportation Policy Board (TPB) meeting.

Discussion: RTP "Local Transit" Growth Assumptions

Gil Cerise and Craigh Helmann, PSRC, provided background on PSRC's regional transportation plan's local transit service assumptions. Initial transit service assumptions were developed based on board direction in Transportation 2040, adopted in 2010. Since then, transit agencies within the region have used the same transit service growth assumptions in development of their own long-range transit plans.

PSRC's Regional Transportation Plan (RTP) must be supported by a reasonable financial strategy. Local transit is the component of the RTP that has the largest funding gap that is assumed to be filled by new revenue sources. Local transit does not include Sound Transit or Washington State Ferries, both of which are covered separately in the RTP Financial Strategy.

Gil and Craig sought transit agency feedback on whether their long-range plans were considered fully funded and affordable to the agencies. The committee discussed the various long range plan assumptions for growth and although each agency had different growth assumptions, the range of growth assumptions they were considering and continuing to consider were like PSRC's existing regional transit service growth assumptions. One key element and potential difference was that transit agencies are focusing first on restoration of service lost due to the pandemic. Once service is restored, the growth assumptions PSRC considers in its regional plans are consistent.

Discussion: Development of future transit networks for RTP

Gil Cerise, PSRC, provided background on the need to update the future transit network for 2050 and an interim year for the RTP. Gil and Craig engaged the committee on possible options for interim-future transit networks and what time point and/or capital projects should be accounted for within that interim network. Gil shared that PSRC will plan to meet with each agency to answer questions on the work that we are asking them to complete. PSRC has established a deadline of April 1, 2025, to provide the future transit networks in time for QA/QC and incorporation into modeling for the RTP (2026-2050).

Discussion: Transit Metrics for the RTP (2026-2050)

Craig Helmann, PSRC shared transit metrics that PSRC typically reports on, highlighting metrics shown on PSRC's RTP dashboard:

https://psrcwa.shinyapps.io/rtp-dashboard/. This includes measuring ridership (boardings), service (revenue hours), efficiency of service (boardings/revenue hour). Transit agencies agreed that these are appropriate metrics that should be continued at the regional level. Agencies will consider whether additional metrics that address regional transit priorities should be incorporated in the future.

Discussion: Agency Nominations to Appoint Transit representation to Bicycle and Pedestrian Advisory Committee

Gil Cerise, PSRC, shared information as a follow-up to the last TOC meeting on other committees that the committee has appointment duties. In this case, the Bicycle and Pedestrian Advisory Committee (BPAC)'s 2024 operating procedures call for TOC to appoint one primary member and one alternate to provide the public transit perspective to the BPAC. Gil shared information on the committee's work program and agencies that have provided transit perspective in the past. Gil clarified that the member and

alternate being appointed by TOC does not have to be a TOC member but should be a staff member who is familiar with pedestrian and bicycle planning and access to transit. In addition, he clarified that PSRC will implement this member by seeking a transit agency to provide the member for the three-year term of the appointment. That means that if staff turns over before the three-year period. PSRC will ask the transit agency to appoint a replacement to fulfill the remainder of that appointment period. Gil will send an email seeking nominations from transit agencies and will schedule an action on this item for the October TOC meeting.

SUBJECT: Appoint transit agency staff to represent transit on the PSRC Bicycle

and Pedestrian Advisory Committee

At the September 25th TOC meeting, PSRC announced a call for nominations from transit agencies to represent transit on PSRC's Bicycle and Pedestrian Advisory Committee (BPAC). Since then, PSRC received two nominations for transit representation on the BPAC for the committee to take action on at the October 23rd meeting.

Background

The <u>September 23rd memo</u> to TOC provided background on the update to the BPAC's operating procedures and transit representation on that committee.

PSRC is seeking transit agency appointments for:

- the BPAC transit agency member position and
- the BPAC transit agency alternate position.

Some clarifications to information provided in the memo include the following:

- Transit representation does not have to be the same as TOC membership.
 Transit agencies are encouraged to identify staff at their agencies who specialize in planning for pedestrian and bicycle access to transit for the BPAC appointments.
- The appointment will be considered a commitment by the agency to provide staff for the term of the appointment (three years). If there is staff turnover in that time period, the agency will directly appoint a replacement. This appointment from TOC will come back to the committee for an action at the end of the three-year period, or sooner if the agency that commits to member and/or alternate position cannot fulfill the staffing request before that time.

 Based upon questions at the September TOC meeting and since then, it should be clarified that cites and counties and WSDOT are already represented on the BPAC.

Since the request for nominations was distributed earlier this month, two agencies have submitted nominations for appointment to the BPAC from transit agencies:

- 1. King County Metro submitted a nomination for Lauren Squires to serve on the BPAC, representing transit.
- 2. Sound Transit submitted a nomination for Kevin Shively (Senior Transportation Planner) to serve on the BPAC representing transit in either a primary member or alternate role.

Both agencies have a history of providing representation from transit on the BPAC. Both nominees would be new to the committee.

Action

At the October 23rd meeting, the TOC will be asked to vote on who will represent transit on BPAC. Given that there are only two nominees, the committee can take action to identify which agency provides the primary member and which agency provides the alternate for the BPAC.

Next Steps

PSRC will reach out to the new member and alternate in advance of the November 12 BPAC meeting to provide an orientation to the committee and its work program prior to its next meeting.

Subject: Development of Transit-Related Work Program for PSRC's FY 2026-27

Biennial Budget

Puget Sound Regional Council (PSRC) is preparing its FY 2026-27 biennial budget and work program with a plan to publicly share information starting in January 2025. As in previous budget cycles, PSRC is sharing its transit-related work program with the Transit Operators Committee (TOC) in advance of sharing it with the transit executives on the Mobility Partnership meeting, prior to releasing it to the public.

Background

In the 2022 project selection cycle, the PSRC Executive Board approved use of FTA Section 5307 funds for future PSRC transit-related work, including the \$2.5 million in FTA Section 5307 plus local match being used for the PSRC FY 2026-27 budget biennium.

The draft work program using these funds is attached to this cover memo. It covers a variety of PSRC's transit-related planning work that reflects ongoing input and feedback from the transit agencies through engagement at TOC. As is currently the practice, PSRC will continue to work closely with transit agencies through the TOC and will make updates and adjustments to the work program, as needed, with the input of the committee.

PSRC intends to continue keeping and updating its TOC "look-ahead" calendar of upcoming topics and will highlight the topics supported by this work program. Over the years, TOC feedback typically focuses on interest and need for knowing when this work will be coming to the committee and seeking transit agency feedback. It is our hope that the TOC look-ahead and ongoing committee communication can satisfy this recurring request.

Attachment A: PSRC FY 2026-27 Transit-related Work Program (July 1, 2025 – June 30, 2027)

Puget Sound Regional Council FY 2026-27 Transit-related Work Program (July 1, 2025 to June 30, 2027)

The PSRC FY 2026-2027 work program will include the following major components providing context for this work:

- Development and adoption of the Regional Transportation Plan (2026-2050).
- Implementation of the Regional Transportation Plan, consistent with VISION 2050.
- Continued work to implement VISION 2050 actions that advance the transit-focused growth strategy in an equitable manner, including supporting the Regional TOD Committee work program.
- Working with transit agencies to update their long-range plans to be consistent with VISION 2050 and the RTP.
- Continued assistance to jurisdictions in implementing VISION 2050 transit-focused regional growth strategy.

The PSRC regional transit work program will directly support these efforts with transit-supportive planning, policy, and data work beyond the standard PSRC Metropolitan Planning Organization (MPO) responsibilities. This work program incorporates both planning and data work subjects, as appropriate.

Based upon past Transit Operators Committee (TOC) requests, PSRC will share updates on how this work program is being implemented on a regular basis at future TOC meetings, using the ongoing TOC meeting calendar as a tool to highlight these topics and the need for future coordination.

VISION 2050

Implementing actions called for in VISION 2050 is the focus of work in this topic area. A notable element of the updated regional growth strategy is an increased emphasis on accommodating future growth in proximity to high-capacity transit, with a goal of 65% of population and 75% of employment locating near existing and planned high-capacity transit service. Among the important transit-related work items implementing VISION 2050 is the development of a Regional Equity Strategy. Other VISION 2050 implementation work includes actions associated with Transit-Oriented Development (TOD) and housing that ensure that TOD is a significant factor in accommodating growth planned within transit station areas and corridors out to a 2050 planning horizon year.

Summary of work products:

- Support for development of the Regional Equity Strategy.
- Continuing the Regional TOD work program and the Regional TOD Committee.
- Regional guidance for Transit Station Area densities and other planning.

Development of Next RTP (2026-2050)

Work on the next RTP was initiated in the previous work program, including the development of future transit networks and associated assumptions, transit financial assumptions among others. This work program will include modeling for the RTP (2026-2050), development of future regional transit and transportation scenarios, analysis of results, and development of transit-related elements of a draft and final Regional Transportation Plan. Illustrative work products under this category will include the following:

- Modeling outputs and analysis of future conditions for the RTP (2026-2050)
- Draft and final transit-related components of the RTP (2026-2050) that will include:
 - o Development and analysis of future transit scenarios for board consideration.
 - A regional transit access assessment.
 - Articulation of transit needs and strategies/next steps to address those needs through 2050 planning horizon.
 - Programmatic analysis and next steps for coordinated mobility plan, transportation demand management, intercity rail and bus, and new technologies and modes such as mobility on demand, among other things.
 - Enhanced guidance for addressing equity in implementation of VISION 2050 and RTP for transit projects.
 - Updates to transit performance metrics and plan outputs.

Regional Transportation Plan Implementation

In Federal Fiscal Year 2027, PSRC will begin work on implementation of the RTP (2026-2050), including transit-supportive elements contained in this work program. Specific next steps will be identified through board discussion, with input from transit agencies through the TOC and other forums. Implementation actions are anticipated to include things like: supporting local governments in implementing comprehensive plans updated in 2024 and updating transit agency long range plans based upon those comprehensive plans, and implementation of regional transit access assessment findings.

Summary of work products:

- Development of resources or technical assistance called for in the RTP that helps transit agencies and local jurisdictions work together to update plans and programs to implement the VISION 2050 regional growth strategy. Examples of implementation resources may include:
 - Next steps or strategies associated with transit and access to transit within the RTP (2026-2050).
 - Strategies associated with the region's Coordinated Mobility Plan to improve mobility for people with disabilities, older adults, and other people with mobility challenges.
 - Next steps or strategies associated with transportation demand management and other transit-related elements.

Ongoing Coordination Efforts and Emerging Issues

PSRC will continue ongoing transit-related coordination and integration efforts, as well as working on emerging issues as they arise. As with past PSRC transit-related work programs, PSRC will continue dialogue with the public transit operators, and update the work program based upon feedback as issues arise. This part of the work program includes work in the following areas:

- Ongoing PSRC support/input at Mobility Partnership (Transit Executives) meetings and associated subcommittees, as needed and requested.
- 2025 Regional Household Travel Survey oversample for transit, including analysis and communicating results to transit partners.
- Continued data and analysis in support of public transit operators, such as analysis of changing travel patterns associated with high-capacity transit expansion, recovery from COVID-19 pandemic, and incorporating these into models. This task includes periodic sharing of trends with public transit operators to assist in their planning work.
- Coordination with public transit operators on data collection and implementation of performance-based planning.
- Regional Transportation Demand Management (TDM) work, including broadening TDM programs and reinforcing their support for public transit.
- Continuing to advance equity, social justice, and similar considerations into the transportation planning process.
