Today's Goal (Continued)

For projects seeking 4 years of funding (for 2025-2029), the committee shall identify whether to allow the regional priority ranking to be used for 4 years or only for 2 years.

When a regional priority ranking is awarded for 4 years,
 PSRC will lose that ranking for the 2027-2029 competition in 2026.

The committee will submit its recommendation to PSRC's Transit Operators Committee (TOC).

Project sponsors announce voluntary withdrawals or any significant changes to their project.

The committee will openly discuss all project requests.

 An explanation for raising or lowering projects based on initial sorting is required. The committee members shall use "deliberation factors" to explain.

Only voting members (or their alternates) may make motions and take votes.

Actions will be by voice vote unless a roll call vote becomes necessary

Overview of Applications Received (Attachment 3A)

24 applications were submitted by 16 unique agencies.

 Seeking \$20.9M for the 2025-2027 and \$2.5M (3 projects) for the 2027-2029.

Project Type:

- 13 Operating (9 sustaining, 4 expansion)
- 6 Capital
- 5 Mobility Management

The majority are "sustaining" existing programs.

Several new agencies are competing for existing/new programs.



Regional Priority Ranking Factors (Attachment 3B)

#1. Preservation of Existing Programs

Is the project needed to support the ongoing operation of an existing program? This includes vehicle replacement and maintenance, or other capital needs to support an existing program at similar service levels.

#2. Addressing Coordinated Mobility Plan's High Priority Strategies

Does the project support the Coordinated Mobility Plan by addressing at least one of the "High" Priority Strategies identified in the plan?

#3. Service Coordination

Does the applicant demonstrate that they coordinate with other operating or mobility management programs serving similar populations within a similar geographic area, including public transit, and avoid unnecessary duplication in services?

Regional Priority Ranking Factors (Attachment 3B)

#4. Performance Measures and Targets

Does the project commit to tracking required performance measures, including at least one equity-focused measure, and set targets for those measures?

#5. Equitable Engagement and Communications

Does the project adequately describe its engagement and communications effort and its alignment with strategies included in PSRC's Equitable Engagement Guidance to better serve equity focus populations within the service area?

PSRC's Equity Focus Populations

- People of color
- People with low incomes
- Older adults (65+)
- Youth
- People with disabilities
- People with limited English proficiency

In addition, equity focus populations include **tribes** within the jurisdictional boundaries of PSRC members.



Summary of Staff Review (Attachment 3A)

For the 2025–2027 biennium, 24 projects applied for priority rankings.

• 3 projects are seeking funding for 4 years.

PSRC can allocate 11 ABC rankings (3 A's, 3 B's, and 5 C's) and unlimited D rankings.

 Attachment 3D provides projects that already received rankings for 2025-2027 in 2022.

Staff Assessment:

- 2 projects received 5 Yes responses
- 2 projects received 4 Yes responses
- 6 projects received 3 Yes responses
- 11 projects received 2 Yes responses
- 3 projects received 1 Yes response

Factors for Consideration in Deliberation

Before the deliberation, the committee will review and develop a final list of Deliberation Factors for the 2025–2027 biennium.

Deliberation Factors used in developing regional priority ranking recommendations in the past are found in Attachment 3 (memo).

- The committee should determine the factors before the deliberation.
- Projects arrayed by PSRC's assessment will be the starting point for discussion.
- The committee must use at least one deliberation factor to make changes in the array of projects for priority rankings.

- Agency equity (# of projects per agency)
- Compelling cases for agencies with limited resources
- Strategic application of federal/state funds
- Coordination
