State Actions to Address Housing

The board heard from former State Representative Frank Chopp about the actions the state has taken to provide more affordable housing. Rep. Frank Chopp discussed the state's housing work and the work of Home and Hope. The Home and Hope team works with the non-profit community partners to reform affordable housing policies and reduce the cost and timelines of housing production. Some strategies for affordable housing include increasing investment in the state Housing Trust Fund, requiring non-profit or public ownership and repurposing under-utilized properties for co-location housing facilities. Regional Priority Rankings for the WSDOT 2025-2027 Consolidated Grant Program

The Transportation Policy Board recommended the Executive Board approve the regional priority rankings for the WSDOT 2025-2027 Consolidated Grant Program. Twenty-four projects were submitted and reviewed based on evaluation factors drawn from the Coordinated Mobility Plan. The projects recommended provide safety net mobility services for priority populations and demonstrate strong coordination with other transportation programs in areas underserved by public transit. <u>View presentation</u>.

Subject: Regional Safety Action Draft Plan

IN BRIEF

PSRC has completed a draft of the Regional Safety Action Plan, funded through the USDOT Safe Streets and Roads for All (SS4A) Grant Program. The Equity Advisory Committee has received multiple briefings throughout the previous year regarding the various components of the plan. At the February 6 meeting, the Equity Advisory Committee will be briefed on the draft plan and ongoing public comment period.

The draft plan has been posted to PSRC's online <u>Engagement Hub</u> and comprehensive outreach to the public and interested stakeholders is ongoing.

DISCUSSION

The Regional Safety Action Plan (RSAP) has been under development since Fall of 2023, following the June 2023 Regional Safety Summit and receipt of grant funding from USDOT's Safe Streets and Roads for All (SS4A) program. The Equity Advisory Committee has been briefed at regular intervals over the last 15 months on key milestones and findings, including the scope of work for the plan, data and analysis results, best practices, emphasis areas, tools and strategies, and community engagement efforts.

In August 2024, PSRC launched the <u>RSAP Engagement Hub</u>, providing information to stakeholders and the public on how they can participate in the development of the plan. The Hub included an online opinion survey and featured key findings and elements of the plan as they were completed. In addition to the online Hub, a comprehensive suite of outreach and engagement has occurred as part of the development of the draft plan.

This has included four regional public meetings, seven focus groups, 31 stakeholder interviews, and tabling at community events around the region. In addition, regular briefings have occurred to PSRC's boards and committees, as well as external partner agency meetings. Feedback from this outreach has informed development of the draft plan, which is now posted on the online Hub for public review and comment.

At the February 6 meeting, the Equity Advisory Committee will be briefed on the release the draft Regional Safety Action Plan for public review and comment. The draft plan is currently posted to the online Engagement Hub and the public comment period is open until February 14th. Any comments will be considered for inclusion into the plan, which is slated to go before the Transportation Policy Board for approval in April. The final plan is scheduled to be adopted by the General Assembly in May 2025.

Subject: Regional Transportation Plan & Coordinated Mobility Plan

IN BRIEF

PSRC staff worked with the Equity Advisory Committee (EAC) to develop a <u>Racial Equity Impact Assessment</u> tool as part of the Regional Equity Strategy. At its February meeting, staff will brief the committee on how PSRC plans to apply the tool to the next Regional Transportation Plan (RTP) and the associated Coordinated Mobility Plan.

DISCUSSION

In 2021, PSRC staff began discussing the need to develop a Racial Equity Impact Assessment (REIA). Intended to help explicitly consider the impacts on racial equity in planning and policy decisions, the assessment is identified as a need in VISION 2050 and the Regional Equity Strategy. Staff worked with the EAC in 2022 to develop the REIA structure, along with guidance and other resources designed to help users understand the purpose and intent of each assessment element. The assessment includes six distinct steps, each with multiple questions, and is designed to ensure that racial equity is considered throughout the policy and plan development process.

As we have previously shared with the committee, PSRC has been working with the Transportation Policy Board to identify regional priorities and focus areas to guide the development of the next RTP, scheduled for adoption in May 2026. The RTP sets transportation investment priorities and goals for cities and counties in the region through 2050. Primary themes have included the continued focus areas of safety, climate, and equity; maintenance and preservation; transit access; ferries; decarbonizing the system; and recognizing the diverse needs and community contexts across the region. In addition to these key topics, the Coordinated Mobility Plan (Coordinated Plan), a component of the RTP, serves as the comprehensive strategy for

identifying and addressing transportation challenges experienced by people with mobility and accessibility needs. These are individuals who have transportation challenges due to their age, income, or ability, including older adults, youth, people with low incomes, people with disabilities, and people with limited English proficiency. The Coordinated Plan encompasses not only specialized transportation services that are targeted to serve populations mentioned above, but also public transit services and accessible sidewalks and bicycle infrastructure. The current Coordinated Plan emphasizes the need to address intersectional equity and potential burdens of communities of color in conjunction with age, income, and ability. PSRC conducts equitable engagement to identify transportation needs of underserved communities and prioritize strategies to address the needs for the plan.

To address the equity theme in RTP more effectively, staff will apply the REIA to the RTP, including the Coordinated Mobility Plan, exploring questions such as:

Early Engagement

- What equitable engagement was conducted?
- What key transportation issues emerged from this engagement, especially from historically marginalized and underserved communities?

Quantitative Data

- What are the key demographics of the region?
- Where are the areas with higher concentrations of equity focus populations (Equity Focus Areas or EFAs) in the region?
- What disparities exist in the region?
- How has structural racism informed regional disparities?

Qualitative Data

- What transportation priorities were identified by EFAs?
- What transportation challenges are experienced by EFAs?
- What are the potential unintended consequences of the RTP investments?

Strategies for Disparities

- How will the priorities and challenges identified by EFAs be addressed?
- What are some strategies to remediate past harms caused by the region's legacy of structural racism?
- How will unintended consequences be addressed in the RTP?

At the committee meeting, PSRC will share more information on incorporating the REIA into the RTP and plans for conducting equitable engagement for the Coordinated Mobility Plan.

NEXT STEPS

Staff will launch key RTP engagement processes in February 2025, via the Coordinated Mobility Plan engagement to populations with mobility and accessibility challenges, and a broadly distributed public opinion survey. PSRC will continue to engage the board, committees, and the public throughout the development of the RTP and the application

of the REIA.
