

Overview of the Project

- Reviewed
 - Strategies for addressing displacement, racially disparate impacts, and exclusion
 - 10 cities' housing sections of their comprehensive plans in the Puget Sound





Overview of the Project

- Analyzed
 - the ways cities developed their comprehensive plans
 - The policies cities included in their comprehensive plans
 - Policy alignment with HB1220

Future housing needs broken down by area median income (AMI) groups



1.1 Million new homes will be needed in the next 20 years

In addition, there will also need to be:

91,357 Emergency housing beds (temporary housing)

Key Takeaways from the Report

- Main Finding:
 - Cities, to varying degrees, incorporated the main elements of the HB 1220 mandate, with those who did more targeted community engagement, having stronger policies

- Main Recommendation:
 - Fund the monitoring of the effects of HB 1220 and support process improvements to help cities reach their housing stock goals

Background: Washington State House Bill 1220

 Requires all comprehensive plans include policies to address and begin to address displacement, exclusion, and racially disparate impacts.

 Washington became the first state to mandate that these issues are addressed as part of the planning process.

 HB 1220 is a critical amendment to the Growth Management Act to ensure municipalities plan for and accommodate affordable housing at all income levels



Processes for Developing Comprehensive Plans

1. Community Engagement

E.g. town hall meetings, partnering with local community based organizations, etc.

1. Alignment with HB 1220 Requirements


E.g. Racially Disparate Impact analysis, estimate current and future housing stock need by income level, etc.

1. Organization

E.g. how many languages in the plan offered in?, does the plan use plain language?, etc.

1. Resources

E.g. financial, data, consulting, and informational



Policy Analysis: Category

- 1. Displacement & Racially Disparate Impacts
 - a. E.g. Emergency Shelters

- 1. Displacement, Racially Disparate Impacts, & Exclusion
 - a. E.g. Mixed-income Housing

- 1. Racially Disparate Impacts & Exclusion
 - a. E.g. Accessory Dwelling Units (ADUs)

- 1. Exclusion & Displacement
 - a. E.g. Manufactured Homes

Policy Analysis: Directive vs. Suggestive Language

<u>Directive:</u> "**Preserve** and maintaining existing manufactured housing parks"

Suggestive: "Consider inclusionary zoning measures"

Policy Analysis: Action vs. Outcome-Oriented

Action-Oriented: "collaborate with other local, regional, and statewide entities to monitor success and progress of incentives, initiatives, and development to ensure policies are working as intended to address racially disparate impacts"

Outcome-Oriented: "Achieve racially and socially **equitable** outcomes in housing"

Example of Best Practice Policy

Policy H-

Kent | Collaborate with other local, regional, and statewide entities to monitor success and progress of incentives, initiatives, and development and to ensure policies are **5.6** working as intended to address racially disparate impacts, displacement risk, and 20-year population allocations. Amend strategies and actions as needed based on monitoring outcomes.

Findings

1. The demographics of cities did not predict which cities had the strongest policies

1. Targeted community engagement is associated with strong policies

Findings (continued)

3. All cities experience challenges funding affordable housing at all income levels

4. A broad spectrum of policy tools were used to address HB 1220

5. Cities do not have a shared understanding of racially disparate impacts, displacement, and exclusion

Recommendations:

For Elected Officials and Government Leaders

 Support Planners and Other Municipal Employees Through Collaborative Governance

Develop a shared understanding of displacement,
RDI, and exclusion
