WSDOT Consolidated Grant

The state consolidates a variety of statewide funding sources to support diverse mobility needs:

- Public transportation within and between rural communities
- Tribal transportation
- Transportation between cities
- Vehicle and equipment purchases
- Specialized transportation for older adults and people with disabilities

One of the only funding competitions for private nonprofit and human service transportation providers.


PSRC works with the Coordinated Mobility and Accessibility Committee (CMAC) to review and prioritize regional applications.



PSRC Regional Priority Ranking Process

WSDOT seeks regional input on projects applying for Consolidated Grant funding.

- Regions express priorities by "grading" projects (A through D)
- Regional Priority Ranking Factors used for application review:
 - Preservation of Existing Programs
 - Addressing High Priority Strategies
 - Service Coordination
 - Performance Measures and Targets
 - Equitable Engagement and Communications





2025-2027 Funded Projects (Attachment A)

In our region, 17 projects were funded for the 2025-2027 biennium:

- 11 Operating:
 - 1 new service
 - 7 sustaining existing service
 - 3 service expansions
- 2 Vehicle Replacement Projects
- 4 Mobility Management Programs

10 projects already received funding in 2022 for the 2023-2027 (two biennia)



Coordinated Mobility Plan

- Highlights transportation needs of the people with accessibility and mobility challenges.
- Lays out **prioritized strategies** addressing the needs.
- Includes a **regional inventory** of existing transportation programs.

Community Feedback on Transportation Needs

- More frequent and expanded transit service coverage, including more services at times/days when needed the most
- Shorter travel times and easy transfers with better crosscounty/cross-agency coordination
- Improved access to healthcare and essential services
- More accessible and safe infrastructure, including more amenities at transit stops (seating, lighting, restrooms)
- More rider education opportunities and awareness



Consolidated Grant Project Implementation:

Funded projects can begin service on July 1, 2025

Coordinated Mobility Plan Development:

- Phase 2 engagement (Priorities and Strategies) will happen July-October 2025
- Continue to develop and refine strategies based on input
- Draft plan expected to be released with Draft RTP
