# **Freight Advisory Committee Meeting Summary**

Date: June 11, 2025, 9:30a.m. - 11:00a.m.

**Location: Remote – Online Meeting Only (Zoom Meeting)** 

#### **Welcome and Introductions**

Doug Cox, PSRC, welcomed everyone at 9:30 a.m. Roll call was completed to confirm the members and alternates present.

**Action: Approval of Meeting Summary** 

The April 9, 2025 meeting summary was approved as presented.

### **Discussion: Regional Transportation Plan Status Update**

Doug Cox, PSRC, shared the Regional Transportation Plan (RTP) work that has been completed and upcoming work as well. Completed work includes updating the current transportation system inventory, an updated Regional Capacity Project list of planned investments in the Region through 2050 and identified the Current Law Revenues estimate through 2050. The gap between estimated revenues and expenditures in about 20-25%, or roughly \$84 billion. Upcoming RTP work includes discussing new revenue sources and/or investment reductions to fill the gap between revenues and expenditures estimated through 2050. In July, the Board will ask PSRC to analyze one or more draft plan scenarios to model. PSRC's results of this analysis will be shared with the Board in the fall for further discussion and draft plan development.

### **Discussion: Regional Supply Chain Considerations**

Doug Cox, PSRC, facilitated a discussion with the committee members regarding how to plan for a resilient supply chain, highlighting how supply chains can be negatively impacted by transportation disruptions.

Bill Ellis, City of Kent, shared the Kent Valley's past and current industrial land, rental prices, and labor sources and costs. He highlighted the large share of industrial land inventory and economic output located in Kent Valley. The area is experiencing high industrial rent, lack of truck parking and cold storage, and electricity demand and supply gap. Bill Ellis recommends PSRC update the purpose of MICs other than just areas for industrial lands can be located. Suggests focusing on livability in these areas and the

amenities in MICs. This may include multimodal access to MICs, workforce development investments, tax policy, research and development incentives in relevant industries.

Ryan Medlen, Northwest Seaport Alliance, explained the Ports of Seattle and Tacoma's role in the Region's supply chain. Warehouse location concentration is moving south which will result in greater transport distances and time to transport goods between the ports and warehouses. This increases transportation costs, consumer prices, and diesel emissions. Ryan reiterated the importance of keeping warehouses and MICs near the ports to increase efficiency and decrease costs of the supply chain.
