The meeting of the Central Puget Sound Economic Development District Board of Directors was called to order at 10:00 a.m. by Tom Florino, President. To determine attendance and that a quorum was present, a verbal roll call was conducted by staff.

#### COMMUNICATIONS AND CITIZEN COMMENT

No requests to provide virtual video, written, or in-person public comment were submitted to staff.

#### PRESIDENT'S REMARKS

President Tom Florino welcomed everyone to the February 2, 2022 meeting and thanked the board members for their attendance.

#### STAFF REPORT

Jason Thibedeau, Economic Development Program Manager, told the board that staff finalized and submitted the adopted Regional Economic Strategy to the EDA for final approval. He also briefed the board on work related to the board focus areas for 2022. Within the Analysis and Strategy Development component, work to date includes finalizing an update to the PSRC's Space Economy Report from 2018. In the Technical Assistance focus area, Jason reminded members of the Build Back Better Regional Challenge, an EDA program to develop and strengthen regional industry clusters across the country, embracing equitable economic growth, good-paying jobs, and enhancing U.S. global competitiveness. He offered staff assistance to jurisdictions or organizations interested in applying for EDA funds. Within the Amplifying Regional Efforts component, staff will be working to identify more opportunities for board members and others to see businesses, educational programs, and other key spaces. Jason asked to hear from

members about ways that PSRC can be helpful to highlight their economic development priorities and successes this year. He noted to members information items in the agenda packet, including the PSRC Draft Supplemental Biennial Budget and Work Program FY2022-2023 and the briefing on PSRC work to facilitate the development of a recovery strategy for the region's arts and culture industry along with ArtsFund. To close, Jason reminded the board that the draft Regional Transportation plan has been released for public comment and the public comment period goes through February 28, 2022.

# **Industrial Lands Analysis Update**

Paul Inghram, PSRC Director of Growth Management, briefed the board on an update to the inventory of industrial lands and to research changing conditions related to industrial uses. He asked for board feedback on the scope of the industrial lands update, which will be coordinated with the Economic Development District Board, PSRC's Freight Advisory Committee, and the Growth Management Policy Board.

Councilmember Stern stated for the record that the scope of Greater Seattle Partners is limited to King, Pierce, and Snohomish counties, and therefore not representative of the PSRC four county region. He noted that the largest greenfield for industrial development in the PSRC region is in Kitsap County, located in the Port of Bremerton. He thus stated that if Greater Seattle Partners, and their goal of business expansion, continued to successfully recruit, Kitsap County would potentially be affected, and that greater coordination with Greater Seattle Partners, PSRC, and Kitsap County would be needed. Councilmember Stern also stated that the original decision by Challenge Seattle to not include Kitsap County within the Greater Seattle Partners framework was shortsighted.

Councilmember Lee commented that the analysis was great, and that recognizing the interconnectedness of the region is important. He stated that even though City of Bellevue doesn't have a large amount of industrial land, that the city is also analyzing the use of the land and how to protect that designation. Councilmember Lee also commented that freight and supply chain issues contribute to the overall picture of how these industries are able to thrive.

#### **DISCUSSION ITEM**

# Regional Workforce Recovery Planning Project Update

Tim Griffith, with MEF Associates, briefed the board on work completed on the Regional Workforce Recovery Planning Project. He provided an update on recent analysis and

the development of the final report detailing project findings along with occupational profiles summarizing key labor market indicators for selected promising occupations.

Councilmember Hougardy commented that this work is incredibly valuable in her jurisdiction, and that access to affordable childcare is a priority.

Pamela Banks, City of Seattle, updated the board that Markham McIntyre will be replacing her at City of Seattle, and she commented that the city plans to focus on workforce development efforts.

Councilmember Lee commented that training providers and community colleges are integral to improving our region's workforce skills. He questioned if the study would identify possible actions these organizations could take to anticipate future workforce needs, as well as these organizations responses. He also questioned what role cities can play in connecting into the existing ecosystem without duplicating efforts. Tim Griffith responded that training providers were contacted and engaged in the study in outreach efforts, and that once the recommendations are finalized, it would provide a point to re-engage with community colleges and training providers. He recognized Councilmember Lee's point that many workforce development structures are already in place, and that this project highlights specific options that are readily available for workers.

Emily Wittman, Aerospace Futures Alliance, commented that she was intrigued by the findings on manufacturing, that there was a ready supply of first year workers, and a lack of workers with 5-10 years of experience. Tim Griffith responded that the current structure of workforce development in the region focuses heavily on getting individuals connected to initial workforce opportunities, but much less focused is placed in industries on continued career development.

Councilmember Nelson stated that the City of Seattle could work to improve on connecting individuals to high wage training programs and wanted to connect to see the compilation of these resources. She questioned what role municipalities could play in providing this workforce information to constituents. Cynthia Forland, of Forland and Wheeler Consulting, responded that the Occupational Profiles in the project should be of use when connecting constituents to these opportunities.

**Subject: Washington Workforce Development Coordination** 

#### **IN BRIEF**

The Washington Workforce Association (WWA) is a membership organization of Washington's Local Workforce Development Boards, which coordinate workforce investments to advance the economic health of their respective communities through a skilled and competitive workforce. Katie Condit, CEO of WorkForce Central and WWA Vice Chair will provide an update on current workforce coordination efforts of the WWA.

#### **DISCUSSION**

The Washington Workforce Association (WWA) is a nonprofit nonpartisan membership organization of the Local Workforce Development Boards (LWDB) of Washington State. The LWDBs are business-led boards that coordinate and leverage workforce investments and strategies with stakeholders from education, economic development, labor and community-based organizations to advance the economic health of their respective communities through a skilled and competitive workforce. The central Puget Sound region is served by four LWDBs: Seattle-King County WDC serving King County, Workforce Snohomish serving Snohomish County, WorkForce Central serving Pierce County, and Olympic Consortium WDC serving Kitsap, Clallam, and Jefferson counties.

As Washington continues to respond to the talent crisis brought about by COVID-19, the LWDBs are positioned to enhance the mechanisms that will upskill and reskill individuals for the future of work. WWA guides the design and implementation of programs and initiatives to maximize equitable opportunity. Existing programs and available jobs can be leveraged to mitigate worker displacement by using data to identify trends to provide individuals with the best information on career pathways and invest in what works. WWA is the driving force in the cohesive union of state and local government agencies, and the tool in building a stronger and more informed workforce-centered network.

WWA provides information, training, tools, and recommendations to policy makers, workforce development professionals, Local Workforce Development Board members, and the community at large to help make informed decisions about how to invest in workforce strategies. WWA works in partnership with other statewide, regional and national organizations advocating for a coordinated, funded system focused on the

needs of job seekers and businesses. WWA brings together the leadership of Local Workforce Development Boards to craft policy, create solutions, and advocate to ensure that the workforce system is positioned to address the economic challenges faced by workers and businesses in our state. At the federal level, The WWA is working to support Congressional reauthorization of the Workforce Innovation & Opportunity Act (WIOA) to support the continued transformation of Washington's workforce development systems. Katie Condit, CEO of WorkForce Central and WWA Vice Chair will provide an update on current workforce coordination efforts of the WWA.

Subject: Arts & Culture Recovery Strategy Update

#### **IN BRIEF**

PSRC is managing a project led by BERK consulting to assist in economic recovery and resiliency for the nonprofits arts and culture industry in the central Puget Sound region. BERK staff will provide an update on the project including initial data analysis and key findings.

#### DISCUSSION

The Arts & Culture Economic Recovery Strategy is leveraging funding from the CARES Act to develop strategies to help the arts & culture industry and workforce recover from the COVID-19 pandemic. The pandemic has had a disproportionate impact on the region's economy, with the arts and culture industry being highly impacted due to the inperson nature of activities and events that are critical to their business models and revenue streams.

The Arts & Culture Economic Recovery Strategy kicked off in February 2022 and is set to be complete in Summer 2022. Early phases of the strategy development have been guided by an advisory committee of representatives from across the region. The strategy builds off the ArtsFund COVID Cultural Impact study, released in January of 2022 and available on the project website.

Staff from ArtsFund will give a brief presentation on the COVID Cultural Impact Study including key findings and relevant data points which informed the scope of the PSRC Arts & Culture Economic Recovery Strategy. Following this, staff from BERK consulting will provide a status update on recent strategy development and data collection efforts. The EDD board will be asked to provide feedback on initial findings that the consultant team will incorporate into the strategy. The consultant team has begun outreach to inform the strategy through key stakeholder interviews, focus groups, and surveys.

# **IN BRIEF**

PSRC staff will provide an update on recent data highlighting demographic and economic trends in the region since the onset of COVID-19, including work status and teleworking trends from the 2021 Household Travel Survey.

#### DISCUSSION

As part of its long-range performance-based planning process, PSRC is involved in an ongoing effort to track a variety of demographic and economic trends across the region. PSRC also collects data through a <a href="Household Travel Survey">Household Travel Survey</a>, which is done on a biannual basis and was performed most recently in Spring of 2021.

Results from the Household Travel Survey provide context for changes from prepandemic baselines. In the survey, 73% of adults reported their work status for pre-March 2020 as working full-time, part time or self-employed, which dropped to 65% in April 2021. This coincided with an increase in those reporting their work status as retired, not employed, or employed but not currently working from 22% to 28% over the same period. Telecommuting also increased substantially during this time, with the estimated share of workers in the region who teleworked at least part time increasing from 16% before March 2020 to 37% in April 2021. The share of workers telecommuting in April 2021 varied across industries, with approximately 80% of workers in the construction, health care, hospitality and retail industries working outside the home. Conversely, most workers in the technology, finance, communications, professional and business services, media and entertainment industries worked from home at least part time.

PSRC staff will provide an overview of initial findings to the EDD board and discuss future analysis which will include analyzing disparate employment impacts based on gender, race and ethnicity.

Save the Date - Regional Connections: Kitsap County on Friday, June 17, 2022 On Friday, June 17, the Economic Development District will be hosting a Regional Connections: Kitsap event for board members and alternates. This is the first in a series of day-long mobile events that will be held in each of the region's four counties and will provide an opportunity for board members to see and hear firsthand about local businesses and economic assets across the region and build connections to collaborate on economic development efforts.

# **Space Economy Update Released**

In February, PSRC released an update to the Washington State Space Economy report, found <a href="https://example.com/here">here</a>. The study found that business activities tied to the space economy contributed an estimated \$4.6 billion in economic activity to Washington communities in 2021. This supports a total of 13,100 jobs and \$1.6 billion in labor income in the state, a doubling of impact since 2018.

# Arts & Culture Economic Recovery Project Kicks Off

The COVID-19 pandemic has had a disproportionate effect on the region's arts and culture industry, due to the importance of in-person experiences. PSRC <u>kicked off a project</u> to assist in economic recovery and resiliency for the nonprofit arts and culture industry in the central Puget Sound region. The EDD Board will receive an update on this project at its May meeting.

# Regional Economic Strategy Approved by U.S. Economic Development Administration

The region's Economic Development District Board adopted the new Regional Economic Strategy in December 2021. In March, the U.S. Economic Development Administration (EDA) approved this work as the region's Comprehensive Economic Development Strategy (CEDS). This approval makes regional jurisdictions and certain organizations eligible to qualify for funding under U.S. EDA programs.

# **Economic Development Element Guide Released**

PSRC released an Economic Development Element Guide in February to assist local jurisdictions with the upcoming 2024 comprehensive plan update process. The guide explains the utility of the economic development element, describes the development of a SWOT analysis, details common data metrics and how to access them, and briefs

planners on the policy-making process. The guide is part of a suite of <u>VISION 2050</u> <u>planning resources</u>. PSRC staff are meeting with local planners to inform technical assistance that will be offered later in the year.

# **Regional Housing Strategy Adopted**

In February, PSRC's Executive Board adopted the <u>Regional Housing Strategy</u>, which lays out regional and local actions to preserve, improve, and expand housing availability in the region and help guide and support upcoming local comprehensive plan updates.

# **Workforce Recovery Planning Project Being Finalized**

The Workforce Recovery Planning project was designed to provide actionable labor market information to a broad array of stakeholders on in-demand occupations and available training programs in the region. The project identified four key industries showing high demand over the next decade: construction, manufacturing, healthcare, and information. Within these industries, the project identified a set of twelve occupations that provide higher-wage and industry-demanded opportunities for the region's jobseekers. Occupational profiles have been developed to provide easy-to-use information for job seekers in the region to pursue these careers. The final report and profiles for the identified opportunity occupations are being prepared for release in May.

# **Industrial Lands Update Progressing**

PSRC is developing an update to the <u>Regional Industrial Lands Analysis</u>, last performed in 2015. Currently, PSRC staff are meeting with local planning and economic development staff to better understand issues in trends across the region, as well as working to update metrics on industrial lands to evaluate the inventory, characteristics, and impacts to the region's economy and communities. A project update will be provided to the EDD Board at its July meeting.

# **Tax Increment Financing Event**

On April 29, 2022, PSRC and ULI Northwest will be co-hosting the <u>Incentives for TOD:</u> <u>TIF and Other Financing Tools</u> event. The event will include experts and practitioners discussing financing tools, including tax increment financing (TIF) - a financing tool that local governments use to fund public infrastructure in targeted areas to encourage private development and investment.
